Market Commentary

- The SGD swap curve flattened yesterday, with swap rates for the shorter tenors trading 1bps lower while the longer tenors traded 2bps lower.
- Flows in SGD corporates were light yesterday, with better buying seen in CMZB 4.875%'27s.
- The Bloomberg Barclays Asia USD IG Bond Index average OAS traded little changed at 1.34% while the Bloomberg Barclays Asia USD HY Bond Index average OAS widened 1bps to 413bps.
- 10Y UST yields traded little changed at 3.06% yesterday.
