

Terms and conditions governing OCBC Cards GSS Spend & Redeem 2014 Promotion ("The Spend & Redeem")

"You" refers to the customer.

"We/ us" refers to OCBC.

Qualifying period

1. To qualify for The Spend & Redeem, you need to incur the specified minimum spend between 30 May and 27 July 2014 (including both dates) ("Qualifying Period").

Spend & Redeem gifts

- 2. You can redeem three (3) different types of gifts:
 - Samsung GALAXY Tab 3 Lite (7.0") WiFi
 - Samsung GALAXY Gear Fit
 - Samsung GALAXY S5 LTE
- 3. There are a total of 900 gifts available for redemption.

- 4. Samsung GALAXY Tab 3 Lite (7.0") WiFi comes in two (2) colours white and black. Colours are available on a first-come, first-served basis and are subject to availability.
- 5. Samsung GALAXY Gear Fit comes in black colour only.
- 6. Samsung GALAXY S5 LTE comes in two (2) colours white and black. Colours are available on a first-come, first-served basis and are subject to availability.
- 7. If any of the gifts becomes unavailable, we have the right to replace it with an item of similar value.

To be eligible

- 8. You are eligible to take part in The Spend & Redeem if you:
 - hold an OCBC principal or supplementary Credit or Debit Card which is in good standing ("Card") (Private Label Cards do not qualify); and
 - meet the following minimum qualifying spend amount within the Qualifying Period:

To participate

9. Step 1: Spend the required minimum qualifying spend amount for the respective gifts within the Qualifying Period.

Step 2: Send SMS Code<space>NRIC<space>Full Name to 76062.

Step 3: Wait for our SMS reply to inform you if you are one of the first 900 Cardmembers who qualify for the gifts.

10. You must send in the SMS in the form specified using a Singapore-registered mobile number. An SMS sent from an overseas number will not qualify.

How we will determine whether you meet the minimum qualifying spend and allocate the 900 gifts

- 11. These Card Transactions qualify:
 - · retail transactions made locally, overseas or online;
 - recurring payment transactions; and
 - new instalment plans. The full purchase amount charged to the Card will qualify.
- 12. These Card Transactions do not qualify:
 - · cash advances;
 - · balance transfers; and
 - the unbilled amount for existing instalment plans.
- 13. Your qualifying spend will be calculated based on all qualifying transactions made on all Cards under your NRIC during the Qualifying Period and posted to the Card Account between 30 May 2014 Singapore Time (SGT) 00:00 and 27 July 2014 SGT 23:59.
- 14. The qualifying spend amount is non-cumulative and you need to meet the respective minimum card spend required for each gift.
- 15. We will not aggregate the spending of the principal Cardmember and supplementary Cardmember together in determining whether the minimum qualifying spend is reached.
- 16. Once you are eligible to participate and you have sent an SMS to register, you can redeem a maximum of one (1) of each of the three (3) gifts. You need to send one (1) SMS for each gift that you would like to redeem.

Gifts are allocated on a first-come, first-served basis according to the time stamp of the SMS(es) in Singapore Time (SGT) as long as the required minimum qualifying spend of the respective gifts has been met and qualifying transactions have been posted to the Card Account at the time of spend verification.
- 18. Gifts are available while stocks last.
- 19. Once you send in the SMS to participate, you will not be able to change your gift(s).
- 20. We reserve the right to debit the full retail value of the redeemed item from any of your accounts with us if you, after successfully redeeming the gift(s):
 - i) terminate the Card account within six (6) months from 27 July 2014; or
 - ii) reverse any of the Card Transactions made during the qualifying period within six (6) months from date of that Card Transaction.

How and where to redeem your gift(s)

- 21. You will receive an SMS notification from us within ten (10) working days after you send the specified SMS to participate to inform you if you are one of the first 900 eligible Cardmembers to successfully redeem a gift.
- 22. To redeem your gifts, please bring along the following from date of receipt of SMS notification till 17 August 2014:
 - a) SMS notification;
 - b) Your OCBC Card; and
 - c) Your NRIC
