



Terms and Conditions Governing OCBC WowDeals and Uber S\$5 Off Promotion: 1 to 31 December 2016 (“WowDeals x Uber S\$5 Off Promo”)

“You” refers to the customer.

“We/us/our” refers to OCBC.

Eligibility

- 1) Promo Code from the WowDeals x Uber Promotion is only valid for
 - the **first 10,000** OCBC Credit/Debit Cardmembers who have reserved the limited deal (“Mobile Coupon”) on the OCBC WowDeals mobile app (“OCBC WowDeals App”) and receive the promo code via an OCBC WowDeals email notification; OR
 - the **first 10,000** OCBC Credit/Debit Cardmembers who have successfully added the Promo Code in the Uber account
- 2) By way of reserving the Mobile Coupon, you agree to register for and accept the Terms and Conditions of this WowDeals x Uber S\$5 Off Promo.
- 3) Promo code is only valid between 01 December 2016 Singapore Time (SGT) 00:00 till 31 December 2016 SGT 23:59 (including both dates) (“Promotion Period”).
- 4) You are eligible to enjoy S\$5 off on your Uber ride if you:
 - hold an OCBC principal Credit or Debit Card which is in good standing (“Card”) (Supplementary Credit Cards, Corporate Cards, Business Cards and Private Label Cards do not qualify);and
 - made payment for your Uber ride with your OCBC Credit/Debit Card stored in the Uber app wallet with the correct Promo Code.

HOW TO GET YOUR PROMO CODE

Step 1:

Reserve the WowDeals x Uber S\$5 Off Promo from the OCBC WowDeals App under “Limited Deals”. Among others, you will be required to provide your email address. The promo code will be sent to that email address.

Step 2:

Open the Uber app and select 'Promotions' under the Menu tab

Step 3:

Key in the promo code to receive the S\$5 off your Uber ride

- 5) In the event that the Uber transaction made is less than S\$5 (the "Relevant Lesser Amount"), you will only be entitled to receive a discount of up to the Relevant Lesser Amount. For instance, if the transaction is only S\$4, you will only be entitled to receive a discount of S\$4. All unutilised credits will be forfeited, and the promo code would be treated as redeemed.

Usage of Promo Code

- 6) Promo code is limited to the first 10,000 for the first 10,000 eligible OCBC Credit/Debit Cardmembers during the Promotion Period.
- 7) Promo Code is limited to one usage per Cardmember and to be used for Uber ride in Singapore only.
- 8) Promo code is available for reservation on the App during the Promotion Period on a "first-come, first-served" and "while stocks last" basis.
- 9) Fares will be deducted accordingly only when promo code has been keyed in before booking of the Uber ride.
- 10) Offers are applicable to the billed amount excluding prevailing GST and booking fee where applicable. An additional Currency Conversion Fee (CCY) will be levied on Uber transactions at the rate of 1% on all converted Singapore dollar amounts.
- 11) We are not responsible for the failure in acceptance and/or processing of such transactions by the merchants including but not limited to non-acceptance of Visa/MasterCard payments, network issue.
- 12) Once used, promo code will not be replaced in the event that Uber Transaction is cancelled or reversed or spend becoming null during the Promotion Period or after the Promotion Period.

General

- 13) We are not responsible for any failure or delay in the transmission or posting of such transactions by any party including but not limited to acquiring banks, merchant establishments, or any telecommunication provider.
- 14) We have the right to end this promotion or change any terms and conditions at any time without giving you notice. This includes changing the number of Mobile Coupons, and/or rules relating to who is eligible for the promotion and the dates of the promotion.
- 15) You allow us to reveal information about you or your account to any person (including the relevant taxi operators and/or the people involved in organising, promoting and carrying out the promotion) (the "Relevant Third Parties") as we see fit. You further acknowledge that you are aware that your personal information/data ("Data") may be transferred and/or disclosed by us to the Relevant Third Parties for the purpose in connection with this promotion (the "Purpose"). Without prejudice to such other rights we may have, you agree and consent to us and the Relevant Third Parties collecting, using and disclosing your Data for any purposes (including without limitation, you agree and consent to your Data being transferred by us to the Relevant Third Parties for the Purpose).
- 16) Our decision on all matters relating to this promotion will be final and binding on all participants. If there is any difference between these terms and conditions and any brochure, marketing or promotional material relating to the promotion, these terms and conditions will prevail.
- 17) The laws of Singapore apply to these terms and conditions, and any disputes between you and us will be dealt with in the courts of Singapore. A person who is not a party to any agreement governed by these terms and conditions do not have any right under the Contracts (Rights of Third Parties Act (Cap 53B) to enforce any of these terms and conditions.
