

## TERMS AND CONDITIONS GOVERNING SINGAPORE GENERAL HOSPITAL CASHBACK PROMOTION

- The SINGAPORE GENERAL HOSPITAL PAY ANYONE CASHBACK PROMOTION (the "Promotion") is open to individuals who meet all the following conditions ("Eligible Customers" or each an "Eligible Customer"):
  - (i) are holders of a personal current and/or savings account with Overseas-Chinese Banking Corporation Limited ("**OCBC Bank**") in Singapore ("**Eligible Account**")
  - (ii) are users of the OCBC Pay Anyone mobile application ("**OCBC Pay Anyone™ App**") in Singapore;
  - (iii) who have made at least one payment using the OCBC Pay Anyone<sup>™</sup> App at Singapore General Hospital's clinics/ pharmacies that accept NETS QR payment;
  - (iv) whose Eligible Account(s) is/are valid, subsisting, in good standing and satisfactorily conducted as determined by OCBC Bank in its sole and absolute discretion; and
  - (v) is not otherwise ineligible or disqualified under these terms and conditions.
- 2. This Promotion is valid from 20<sup>th</sup> June to 20<sup>th</sup> July 2018 ("Promotion Period").
- 3. This Promotion is not valid for any doctor consultation fees.
- 4. Cash back amount is \$2 per eligible transaction. An eligible transaction refers to a minimum spend of \$20 in a single receipt made with the OCBC Pay AnyoneTM App at Singapore General Hospital's clinics/ pharmacies during the Promotion Period.
- 5. This Promotion is limited to the first 30,000 Eligible Customers only. There is no limit to the number of cash back amount as long as the corresponding number of eligible transactions are made by an Eligible Customer.
- 6. The cash back earned will be credited in the Eligible Customer's account used with the OCBC Pay Anyone<sup>™</sup> App for the transactions within 2 months from the end of the Promotion Period.
- 7. Participation in the Promotion is subject to these terms and conditions and the Customers are deemed to have accepted these terms and conditions when they participate in the Promotion.
- 8. In the event of any inconsistency or discrepancies between these terms and conditions and any brochure, marketing or promotional material relating to the Promotion, these terms and conditions will prevail.
- 9. OCBC Bank shall not be responsible for:-
  - any failure or delay in the transmission of the Eligible Transactions, sale transactions or receipt of evidence of sale transactions by acquiring merchants, merchant establishments, card associations, postal or telecommunication authorities or any other parties which may result in a charge made by the Eligible Customer being omitted (whether from being posted to the Eligible Customer's account and/or captured in OCBC Bank's system or otherwise) during the Promotion Period;
  - (ii) any late posting of the Eligible Transactions or for any failure in the Eligible Transactions being transacted by the Eligible Accounts or being captured in OCBC Bank's system; or
  - (iii) any breakdown or malfunction in any computer system or equipment; or
  - (iv) any loss to or expenses of any Eligible Customer or any other person in connection with the Promotion, howsoever arising.
- 10. This Promotion shall not apply in conjunction with any other privileges or promotions unless otherwise stated.
- 11. OCBC Bank's decision on all matters relating to this Promotion shall be final, conclusive and binding on the Customer. OCBC Bank shall not be obliged to give any reason or enter into any



correspondence with the Customer or any persons on any matter concerning this Promotion and no appeal, correspondence or claims will be entertained.

- 12. Notwithstanding anything in these terms and conditions, OCBC Bank reserves the right at any time and from time to time in its absolute discretion to terminate the Promotion or to determine and/or amend, any of the terms and conditions herein, without giving any reason or prior notice.
- 13. A person who is not a party to any agreement governed by these terms and conditions shall have no rights under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce or enjoy the benefit of any term of such agreement.
- 14. These terms and conditions shall be governed by the laws of the Republic of Singapore and all Customers who participate in this Promotion shall be deemed to have irrevocably agreed to submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
