

## Terms and Conditions governing the OCBC Bank Free Eco Bag at Esso service stations:

## 15 Oct 2015 - 14 Nov 2015

- 1. This promotion is valid for all OCBC Bank Credit / Debit Cards except private label cards.
- 2. Subject to these terms and conditions, in order for a OCBC Bank cardmember to be eligible for a free Eco Bag, the OCBC Bank cardmember must purchase at least \$\$60 worth of fuel in one transaction (based on gross spend) at any Esso service station in Singapore, and charge the purchase to an OCBC Bank Credit / Debit Card via Visa / MasterCard card transaction, in a single receipt. Limited to one Eco Bag per transaction.
- 3. The Eco Bags' colours and designs are subject to availability at Esso service stations and on a "while stocks last" basis.
- 4. To redeem the free Eco Bag in-store, Speedpass customers have to present the receipt together with the relevant OCBC Bank Credit / Debit Card that is linked to the Speedpass tag used as proof of purchase. The last four digits of the card number displayed on the card presented must match the last four numbers printed on the receipt in order for the customer to qualify for the redemption of the Eco Bag.
- 5. NETS and cash transactions are not eligible for this Promotion.
- 6. The decision of OCBC Bank on all matters relating to this promotion is final, conclusive and binding on all participants and no correspondence will be entertained.
