

<u>Terms & Conditions of the OCBC Mighty Savers® BYKidO Promotion (the "Promotion")</u>

Eligibility Criteria

- 1. This is a one-time promotional offer for customers who:
 - (a) hold an existing OCBC Child Development Account with OCBC Bank; and
 - (b) sign up for an OCBC Mighty Savers® Account jointly with their child by 30 April 2019.
- 2. Customers who already have an existing OCBC Mighty Savers[®] Account, or any account under the OCBC Mighty Savers[®] Programme (see Appendix 1), will not be eligible for the Promotion.
- 3. Customers who fulfil the conditions set out in clauses 1 to 2 above shall be entitled to receive [one (1) BYKidO Pass] (the "Gift").
