

# Terms & Conditions Governing the OCBC Mighty Savers® Lucky Draw Promotion 2019

## **Eligibility Criteria**

1. The OCBC Mighty Savers® Power of Saving Lucky Draw ("Promotion") is open only to individual customers who maintain any of the following accounts ("Qualifying Accounts") with Oversea-Chinese Banking Corporation Limited ("OCBC") in Singapore ("Eligible Customer").

Qualifying Accounts refer to the following accounts under the OCBC Mighty Savers® Programme:

"Qualifying Child" shall refer to an individual below the age of 16 years, and "Eligible Person" shall refer to an individual of at least 21 years of age.

- 2. To participate in the Promotion, the Eligible Customer must fulfil the following criteria:
  - a. do a one-time registration for the Promotion by submitting the following details at bit.ly/MSluckydraw2019:
    - i. Name of Parent;
    - ii. Name of Child;
    - iii. Account number under the OCBC Mighty Savers® Programme;
  - b. deposit the Qualifying Amount in Fresh Funds (as defined in clause 4 below) into any of the Qualifying Accounts during the Qualifying Period, as follows:

- c. have an Incremental Balance corresponding to the relevant Deposit Offer (as set out in the third column in Table 1 above) as at the end of November. The Incremental Balance is determined by comparing the account balance in the relevant Qualifying Account on the last day of July against the account balance of such Qualifying Account on the last day of November.
- 3. The Qualifying Amount cannot be aggregated from multiple transactions in a Qualifying Account or across Qualifying Accounts; it must be a one-time deposit of S\$500 to S\$799, S\$800 to \$999 or S\$1,000 and above into a single Qualifying Account.
- 4. "Fresh Funds" refer to funds that: (a) are not transferred or withdrawn from existing OCBC Bank deposit accounts and re-deposited; (b) are not in the form of OCBC Bank cheque / cashier's order / demand drafts.
- 5. There is no limit to the number of lucky draw chances that an Eligible Customer can earn in relation to each Qualifying Account.

- 10. Winners will be announced on our OCBC Facebook page within seven days from the relevant draw date. We will also send a notification letter to the mailing address registered with the Qualifying Account.

Requests to claim prizes 4 weeks after the date of the letter will not be entertained.
