

## **Terms and Conditions pertaining to the NTUC/OCBC Plus! Visa Card Caltex Fuel Discount Promotion**

These Terms and Conditions shall govern and apply to the NTUC/OCBC Plus! Visa Card Caltex Fuel Discount Promotion (The "Promotion")

### **The Promotion**

Under the Promotion, a NTUC/OCBC Plus! Visa cardholder (the "Cardholder") will be entitled to receive an instant 18% fuel discount during the Promotion Period for all grades of petrol and diesel at Caltex. This fuel discount stated is inclusive of prevailing 5% site discount and 13% NTUC/OCBC Plus! Visa card discount. In addition, 0.2% LinkPoints rebate will be credited by OCBC Bank based on nett fuel purchases for every S\$1 charged to his NTUC/OCBC Plus! Visa Card.

### **General Terms of the Promotion**

1. The Promotion is valid from 17 April 2017 to 31 December 2019 or such date as may be determined by OCBC and Chevron Singapore Pte. Ltd. ("Chevron") from time to time (the "Promotion Period").
2. In order for the Cardholder to be eligible for the promotion, payment must be made indoors and charged to a NTUC/OCBC Plus! Visa Credit or Debit Card.
3. In addition, every litre of fuel pumped with your NTUC/OCBC Plus! Visa Credit or Debit Card at Caltex earns you 3 LinkPoints under the Plus! Programme. 150 LinkPoints is equivalent to S\$1.00. 7. These terms and conditions shall be governed by the laws of Singapore and the participants in this Promotion irrevocably submit to the non-exclusive jurisdiction of the courts of Singapore.

8. A person who is not a party to the agreement governed by these terms and conditions shall have no right under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any of these terms and conditions.
