

## Terms and Conditions for the OCBC 360 Online Account Opening Promotion (S\$100 Cash Reward) (the "Promotion")

### 1. General Terms and Conditions

- 1.1 This Promotion is open to the first 1,000 qualifying new OCBC 360 Account holders.
- 1.2 The promotion period shall be from 3 September 2018 to 30 September 2018 (both dates inclusive), or such other period(s) as may be determined by Oversea-Chinese Banking Corporation Limited ("OCBC Bank") in its absolute discretion (the "Promotion Period").

### 2. Eligibility

- 2.1 This promotion is only applicable to new OCBC 360 Account holders who do not have any salary crediting arrangement with OCBC Bank within the period 6 months prior to the Promotion start date of 3 September 2018.
