
## Summary (as of 5 Feb 2020)


# Statistics: Daily increase of suspect cases rebounded again up by a record 5328. Total confirmed cases reached 28018

# Situation in Hubei Province: Fatality rate in Wuhan fell further to 4.1%. The daily increase of suspect cases rebounded again yesterday. On the positive note, the number of people under medical observation fell for the first time. (Chart 16)

# Situation outside Hubei province: Fatality rate outside Hubei Province was at 0.2%. 6.1% of patients outside Hubei province have recovered. Daily increase of new confirmed cases stabilized.

# Our thoughts: Suspect cases in Hubei province rebounded again. It is not a easy battle. The most encouraging data yesterday was the first decline of number of people under medical observation in Hubei province (chart 16), which reinforced the hopes that China's unprecedented efforts to contain the virus in the epicentre may pay off gradually. The key focus to me is still on the risk of second wave contagion after migrant workers return. We haven't seen evidence of that yet, which is a good news I suppose.
