# Terms & Conditions Governing 'OCBC 365 Credit Card Online Promotion March-May 2018 (The Promotion)'

### **Promotion Period**

1. The promotion period is defined as from 29 March 2018 to 31 May 2018, both dates inclusive (the "Promotion Period").

## Eligibility

2. You are eligible to participate in the Promotion if you are not an existing OCBC Credit Card Principal holder. For the avoidance of doubt, existing OCBC Credit Card supplementary cardholders who do not hold any existing OCBC Credit Card as the main cardholder is eligible to participate in this Promotion.

#### Cashback and Gift Card

3. Each eligible customer will receive (the "Eligible Customer"):

Cashback	Criteria	
(a) S\$50 Cashback	(i)	You make an application for an OCBC 365 Principal Credit Card via Burpple website ("Eligible Website") during the Promotion Period and your application is successfully approved by OCBC by 30 June 2018; and
	(ii)	You charge at least \$\$300 to your OCBC 365 Principal Credit Card by 31 July 2018.

- 4. Subject to fulfilment of Clause 3(a) above to the absolute satisfaction of OCBC, an amount of \$\$50 will be credited to the Eligible Customer's 365 Card account by the end of 31 August 2018.
- 5. For the avoidance of doubt, each Eligible Customer is only entitled to receive a maximum of S\$50 cashback amount upon fulfilment of Clause 3(a) above and Card applications submitted through other promotion channels i.e. not the Eligible Websites, will not be eligible for this Promotion.
- 6. Applicants who had cancelled any existing OCBC Principal Credit Card within the last 6 months prior to the Promotion Period and re-applied for it under this Promotion are not eligible to participate in this Promotion.

#### General
