

## Terms and Conditions governing Spend & Redeem Free Cookies Campaign

1. This Promotion is valid for holders of all NTUC/OCBC Plus! Visa Credit and Debit Cards (the “Plus! Visa Card”) from 23 July to 19 August 2018 (both dates inclusive) (the “Promotion Period”).

### Promotions

#### 2. **Promotion 1: FairPrice Supermarkets**

- a. Holders of the Plus! Cards (the “Plus! Cardmembers”) will receive one pack of O&T cookies (120g, U.P. S\$2.40) when they spend a minimum of S\$50 in a single receipt (“Spend Amount”) with their Plus! Visa Card at **FairPrice Supermarkets (excluding FairPrice Finest and FairPrice Xtra) during the Promotion Period.**
- b. Type of Cookies will be changed every Monday, in the following order:
  - 23 Jul – 29 Jul: Chocolate Melts cookies
  - 30 Jul – 5 Aug: Chocolate Chip Raisin cookies
  - 6 Aug – 12 Aug: Double Chocolate Chip cookies
  - 13 Aug – 19 Aug: Blueberry Jam cookies
- c. The pack of O&T cookies will be issued at the counter where payment is made. For self-checkout counters, the pack of O&T cookies can be redeemed from the self-checkout attendant.

#### 3. **Promotion 2: FairPrice Finest and FairPrice Hyper**

- a. Holders of the Plus! Cards (the “Plus! Cardmembers”) will receive one tin of Home’s Favourite cookies (130g, U.P. S\$10.80) when they spend a minimum of S\$100 in a single receipt (“Spend Amount”) with their Plus! Visa Card at **FairPrice Finest and FairPrice Xtra.**
- b. Type of Cookies will be changed every Monday, in the following order:
  - 23 Jul – 29 Jul: Durian cookies
  - 30 Jul – 5 Aug: Milo Dinosaur cookies
  - 6 Aug – 12 Aug: Singapore Laksa cookies
  - 13 Aug – 19 Aug: Lychee cookies
- c. The tin of Home’s Favourite cookies is to be redeemed at the Customer Service Counter at the respective stores.

Redemption is on a while stocks last, on a first-come, first-served basis. Redemption must be completed in the same store and on the same day of the qualifying purchase.
