

## **Terms & Conditions Governing the 'OCBC SCORE FairPrice/Grab Rebate Promo' (the "Promotion")**

### **Promotion Period**

1. The promotion period shall be from 8 November 2018 to 8 November 2019 (both dates inclusive), or such other period(s) as may be determined by Oversea-Chinese Banking Corporation Limited ("OCBC Bank") in its absolute discretion (the "Promotion Period").

### **Eligibility**

2. This Promotion is only applicable to existing OCBC Cardmembers who, during the Promotion Period are:
  - (a) existing SCORE members holding any Eligible Cards (as defined in Clause 4 below); and
  - (b) have activated their OCBC-SCORE benefits via SCORE ([www.scoresg.com](http://www.scoresg.com)) 'My Benefits & Profile' page.

For the avoidance of doubt, only one Eligible Card can be selected by the OCBC Cardmember for the OCBC-SCORE benefits at any given time. Existing supplementary OCBC credit cardholders are eligible to participate in this Promotion. However, rebates earned by a supplementary OCBC credit cardholder can only be credited into the Eligible Card account of the principal OCBC credit cardholder.

3. Subject to the fulfilment of Clause 2 above, OCBC Cardmembers will be eligible to enjoy the OCBC-SCORE benefits described in Clause 5 below until the expiration of their SCORE membership, or for 1 calendar year starting from the OCBC-SCORE benefits activation date, whichever is earlier.
4. This Promotion is only applicable for OCBC benefits activation made for the following OCBC Cards (the "Eligible Cards"):
  - (a) OCBC Plus! Visa Credit Card;
  - (b) NTUC Plus! Visa Credit Card;
  - (c) OCBC Plus! Visa Debit Card;
  - (d) NTUC Plus! Visa Debit Card; or
  - (e) FRANK Visa Debit Card.
5. OCBC Cardmembers who successfully activated the OCBC-SCORE benefit specified in Clause 2 above will be entitled to the following benefits:
  - (a) 3% rebate for increment spends above SGD100 in a single receipt at FairPrice, FairPrice ON, FairPrice Finest, FairPrice Xtra, Unity stores and Warehouse Club with a cap at SGD5 per transaction.
  - (b) 5% rebate for Grab car rides starting from the 6<sup>th</sup> ride with a cap at SGD10 per OCBC Customer per calendar month. The first 5 qualifying rides must be non-discount rides on all services except GrabCycle, GrabHitch, GrabShuttle, GrabShuttlePlus, GrabCoach.
6. Subject to the fulfilment of Clause 5 above to the absolute satisfaction of OCBC Bank, the consolidated rebate amount will be credited into the Eligible Card account of the OCBC Cardmember (or in the case of a supplementary OCBC credit cardholder, the account of the principal OCBC credit cardholder) within 60 days in which the spend occurred.
7. For the avoidance of doubt, if the SCORE membership expires before the last calendar day of month, the SCORE member can earn and will still be awarded the rebate up until the membership expiry date.
8. The rebate earned and awarded to the OCBC Cardmember applies specifically to the Eligible Card activated via SCORE ([www.scoresg.com](http://www.scoresg.com)) 'My Benefits & Profile' page. If the OCBC Cardmember

changes the Eligible Card to earn the rebate on, the OCBC-SCORE benefit will only be awarded for the latest activated Eligible card in the calendar month.

9. The rebate awarded under the OCBC-SCORE benefits via SCORE is separate and in addition to any other existing rebate programme involving NTUC/OCBC Plus! Visa Card or Frank Visa Debit Card.
10. OCBC Bank shall use information received from the owners of the SCORE programme (including but not limited to, personal data, phone number, email address, delivery/billing address, and payment details for programme fees) for the purposes of rebate computation under this Promotion.

#### **General**

11. OCBC Bank reserves the right at its absolute discretion to terminate this Promotion or vary, delete or add to any of these terms and conditions from time to time without notice including without limitation, the eligibility of any customer and the dates of this Promotion.
12. OCBC Bank's decision on all matters relating to this Promotion will be at its absolute discretion and will be final and binding on all participants. No correspondence shall be entertained. In the event of any inconsistency between these terms and conditions and any brochure, marketing or promotional material relating to this Promotion, these terms and conditions will prevail.
13. These terms and conditions shall be governed by the laws of Singapore and the participants in this Promotion irrevocably submit to the non-exclusive jurisdiction of the courts of Singapore. A person who is not a party to any agreement governed by these terms and conditions shall have no right under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any of these terms and conditions.
