

Terms and Conditions governing the OCBC Titanium Rewards 10 OCBC\$ (worth 4 Miles) Dining Campaign ("Promotion")

## **Promotion Period**

1. The Promotion Period is defined as the relevant calendar month in which you receive the short message service ("SMS") or such other period as may be determined by Oversea-Chinese Banking Corporation Limited ("OCBC Bank") in its absolute discretion ("Promotion Period").
