Terms and conditions governing OCBC Cards CNY 2017 Caltex New Moon Abalone Promotion

"You" refers to the customer.

Promotion Period

1. The Caltex New Moon Abalone Promotion (the "Promotion") is only available to holders of OCBC credit/debit Cards (other than Private Label cards and Corporate Cards) ("OCBC Cardmembers") from 8 December 2016 till 15 February 2017 (15th February 2017 inclusive) (the "Relevant Period").

The Promotion Item

- 2. The following are the promotions offered to OCBC Cardmembers during the Relevant Period:
- (i) If an OCBC Cardmember makes a minimum charge of S\$40 gross fuel spend (before discount) on his/her OCBC credit/debit card (other than Private Label Cards and Corporate Cards) ("OCBC Card") at any Caltex service station in Singapore ("Caltex service station") in a single receipt, he/she is entitled to receive a S\$4 off (a) every set of New Moon Abalone or (b) every can of New Moon Abalone that he/she purchases at any Caltex service station . For the avoidance of doubt, the charges incurred for the fuel and the purchase of the New Moon Abalone must all be reflected under a single receipt in order for an OCBC Cardmember to be entitled to this offer.

As an example, if an OCBC Cardmember purchases 1 can and 1 set of New Moon Abalone at any Caltex service station (and assuming that he/she has charged a minimum of S\$40 gross fuel spend (before discount) on his/her OCBC Card), he/she will be entitled to receive S\$8 off (i.e. 2 x S\$4) from the total purchase price paid for the 1 can and 1 set of New Moon Abalone.

(ii) If no fuel spend is charged to the OCBC Card by the OCBC Cardmember or should the minimum charge of S\$40 gross fuel spend (before discount) not met, the OCBC Cardmember is entitled to S\$4 off from the total purchase price paid for every 2 cans/sets of New Moon Abalone purchased by the OCBC Cardmember at any Caltex service station. (iii) An OCBC Cardmember is entitled to purchase a set of 2 cans of New Moon South Africa Abalone at \$\$50 (U.P. \$\$100) at any Caltex service station *except Caltex Jalan Buroh*.

In addition to the offer set out in this Clause 2(iii), an OCBC Cardmember is also entitled to enjoy the offers set out in Clause 2(i) and 2(ii) provided that the conditions set out therein are met. For the avoidance of doubt, there is only a total maximum of 1,200 sets of New Moon South Africa and it is available on a while stocks last basis.

3. Subject to these terms and conditions, each OCBC Cardmember can purchase as many cans and/or sets while stocks last basis, and be entitled to the above promotions as long as they satisfy the conditions stated in Clause 5 below during the Relevant Period and that the purchases are charged in a single receipt.

4. Both the New Moon Abalone and New Moon South Africa Abalone cans and sets are available on a first come-first served basis, while stocks last.

How to qualify for the Promotion and Proof of transactions

- (i) holds an OCBC principal or supplementary OCBC Card which is in good standing;
- (ii) (in relation to Clause 2(i)) makes the fuel spend on his/her OCBC Card during the Relevant Period; and
- (iii) purchases the relevant New Moon Abalone products using his/her OCBC Card; and
- (iv) purchases the relevant New Moon Abalone products at any Caltex service station (save that the offer set out in Clause 2(iii) is not available at the Caltex service station at Jalan Buroh.
- 6. Chevron Singapore Pte. Ltd. ("Chevron") and OCBC Bank will not reserve any cans/ sets for any person or entertain any request to transfer them to another outlet or another person.
