

Terms and Conditions governing the OCBC Titanium Rewards Contactless Activation and Usage 30 OCBC\$ and NTUC vouchers worth S\$25 Campaign ("Promotion") from 20 November to 19 December 2018 ("Promotion Period")

## <u>Eligibility</u>

- 1. To qualify ("Qualified Cardmembers"):
  - (a) You must be an OCBC Titanium Rewards Cardmember who has received an electronic direct mail (EDM) or SMS from Oversea-Chinese Banking Corporation Limited ("OCBC Bank"), inviting you to participate in this Promotion.
  - (b) To qualify for NTUC vouchers worth S\$25, you must be amongst the first 1,000 Qualified Cardmembers to register your OCBC Titanium Rewards Card at <u>https://abt.transitlink.com.sg/Account/Registration</u>, and use your card at least once either on train or bus rides during the Promotion Period.
- 2. The invitation to participate in this Promotion is not transferrable.

## **Rewards**

- 3. Qualified Cardmembers will earn 30 OCBC\$ ("Bonus OCBC\$") for every dollar spent, capped at \$\$500, on train and bus rides, using their OCBC Titanium Rewards Card during the Promotion Period.

- 6. Bonus OCBC\$ will be credited to the Qualified Cardmembers' Principle OCBC Titanium Rewards Card account by 31 January 2019.
- 7. Vouchers will be mailed to the Qualified Cardmembers' mailing address as per OCBC Bank's record by 31 January 2019.



- 8. Qualified Cardmembers' Card account must be active and in good standing at the time of crediting.

- 10. OCBC Bank reserves the right to change or substitute the Vouchers and OCBC\$ with any item of similar value without notice.
