

# Terms and Conditions Governing the OCBC Card Sign-up S\$80 Gojek Credit Promotion for Gojek Customers (the "Promotion")

## 1. Eligibility

- 1.1 The Promotion period starts from 6 December 2019 and ends on 29 February 2020 ("Promotion Period").
- "Eligible Customer" means a Gojek customer who has no existing OCBC Credit Card with OCBC at the point of application and did not terminate any OCBC Credit Card in the last 12 months. Existing supplementary OCBC Credit Cardholders who do not hold any OCBC Credit Card as a principal cardholder are eligible to participate in this Promotion.

#### 2. Promotion Mechanics

### S\$80 Gojek Credits

- 2.1 The Promotion is open to Eligible Customers who apply for any OCBC Credit Card online via <a href="https://www.ocbc.com/personal-banking/Cards/cpa/ocgj80/index.html">www.ocbc.com/personal-banking/Cards/cpa/ocgj80/index.html</a> during the Promotion Period, and his/her OCBC Credit Card application is approved by OCBC on or before 31 March 2020. OCBC Credit Card applications submitted through other channels will not be eligible for this Promotion.
- 2.2 This Promotion is only applicable for applications made for the following OCBC Credit Cards (the "Eligible Cards"):
  - a. OCBC 365 Credit Card;
  - b. FRANK Credit Card;
  - c. OCBC Plus! Visa Credit Card;
  - d. NTUC Plus! Visa Credit Card;
  - e. OCBC Cashflo Credit Card;
  - f. OCBC Great Eastern Cashflo Credit Card;
  - g. OCBC Robinsons Group Credit Card;
  - h. OCBC Titanium Rewards Credit Card (blue);



- i. OCBC Titanium Rewards Credit Card (pink);
- j. OCBC Arts Credit Card;
- k. OCBC Best Denki Credit Card;
- I. OCBC Platinum Credit Card; and
- m. OCBC 90°N Card.
- 2.3 The first 350 Eligible Customers who fulfil the criteria specified in Clauses 2.1 and 2.2 above ("Qualified Customer") will qualify for \$\$80 Gojek credits (the "Credits"). Credits will be in \$\$10 denominations.
- 2.4 The Credits will be awarded to the Qualified Customer via Promo code sent by SMS, by the end of the following month from the date of card approval, i.e. if the Qualified Customer's card was approved on 1 January 2020, he/she will be receive the SMS by 29 February 2020.
- 2.5 The promo code is valid till 31 August 2020 and may only be enrolled in the Gojek Application to redeem Voucher(s) within the validity period.
- 2.6 The corresponding Voucher(s) redeemed upon successful enrolment of the Promo Code are only valid for the GoCar service in Singapore, and may only be applied to GoCar order requests made within 90 days from the date of redemption

#### 3. General

- 3.1 This Promotion is not valid in conjunction with any other offers or promotions, unless otherwise stated.
- 3.2 OCBC reserves the right to terminate this Promotion or vary, add or delete any of these terms and conditions without notice, including without limitation, the eligibility of any Eligible Customer and the dates of this Promotion.
- 3.3 OCBC's decision on all matters relating to this Promotion will be final and binding on all participants. In the event of any inconsistency between these terms and conditions and any brochure, marketing or promotional material relating to the Promotion, these terms and conditions shall prevail.
- 3.4 These terms and conditions shall be governed by the laws of Singapore and the participants in this Promotion irrevocably submit to the non-exclusive jurisdiction of the courts of Singapore. A person who is not a party to any agreement governed by these terms and conditions shall have no right under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any of these terms and conditions.
