

Terms and conditions governing the STACK Sign-Up Rewards Campaign – January 2020 ("Promotion")

### **Promotion Period**

1. The "Promotion Period" is defined as the period from 17 January 2020 till 16 February 2020, (both dates inclusive), or such other date(s) as may be determined by OCBC Bank in its sole and absolute discretion from time to time without prior notice ("Promotion Period").

# Eligibility

- 7. To use the Voucher, simply copy and paste the 'Voucher Number' as the promo code at the checkout page.
- 8. Voucher is applicable on lazada.sg, Lazada iOS or Lazada Android App only.
- 9. Voucher is not applicable for Digital Goods, Toddler Formula (0-12mths) and Gold SKUs.
- 10. Voucher is not applicable for RedMart products.
- 11. Voucher is not applicable for over the counter (OTC) medicine and delivery charges.
