# Terms and Conditions Governing the OCBC 365 Credit Card Hotel Dining Cashback Promotion (the "Promotion"):

These Terms and Conditions together with the terms of the Terms and Conditions Governing the OCBC 365 Credit Card Cashback Programme (as may be amended, modified and supplemented by OCBC from time to time) shall govern and apply to the Promotion.

## **Promotion Period**

1. The promotion period will be from 1 December 2015 to 31 March 2016 (both dates included) or such other period as may be determined by Oversea-Chinese Banking Corporation Limited ("OCBC") in its absolute discretion (the "Promotion Period").

## Eligibility

- 2. You are eligible to take part in the Promotion ("Eligible Cardmembers") if:
  - (a) You are an existing OCBC 365 Credit Cardmember;
  - (b) your OCBC 365 Credit Card account is in good standing with OCBC during the Promotion Period:
  - (c) you must spend a minimum of S\$600 based on posted transactions in a calendar month on the OCBC 365 Credit Card (the "Minimum Spend Requirement"). The spending can be aggregated between the Principle and Supplementary Cardmembers and is only valid for retail transactions.

#### **Promotion**

- 3. Subject to you satisfying the conditions stated in Clause 2 of these terms and conditions, each Eligible Cardmember will be awarded with the following cashback on all Hotel Dining in Singapore:
  - (a) 6% cashback on weekends (Saturdays to Sundays)
  - (b) 3% cashback on weekdays (Mondays to Fridays)
- 4. If an Eligible Cardmember does not meet the Minimum Spend Requirement, he/she will earn cashback of 0.3% on all retail spends; including all Hotel Dining spends in Singapore.
- The cashback on all Hotel Dining in Singapore is promotional and will be in addition to the cashback earned in accordance to the Terms and Conditions Governing OCBC 365 Credit Card Cashback Programme.
- 6. For the avoidance of doubt, this Promotion is only available during the Promotion Period and it shall terminate upon the expiry of the Promotion Period.
- 7. The total cashback awarded under this Promotion and under the OCBC 365 Credit Card Cashback Programme will be aggregated and capped at S\$80 based on posted transactions per each calendar month.
- 8. In the event of any ambiguity, OCBC retains the right to determine whether a particular transaction qualifies as a "retail transaction".
- 9. OCBC has the right to end or withdraw the Promotion without giving you notice.

#### Miscellaneous

- 10. OCBC's decision on all matters relating to the Promotion will be final. If there is any difference between these terms and conditions and any brochure, marketing or promotional material relating to the Promotion, these terms and conditions will apply.
- 11. OCBC will not be responsible or held liable for any loss to or expenses you or any person incur in connection with the Promotion, including any error in computation, any breakdown or malfunction in any computer system or equipment.
- 12. We have the right to change any terms and conditions without giving you notice. This includes changing the rules relating to who is eligible for the Promotion and the dates of the Promotion.
- 13. The laws of Singapore apply to these terms and conditions, and any disputes between the participants and OCBC will be dealt with in the courts of Singapore. A person who is not a party to any agreement governed by these terms and conditions has no right under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any of these terms and conditions.
