

Terms and Conditions Governing the OCBC Titanium Rewards 15X Electronics/Gadgets and 5X OCBC\$ Dining Campaign from 18 September to 30 September 2017 (the "Promotion")

- 4) Annual Card fees, Cash-On-Instalment IPP, extended payment plan, income tax payment, bill payments made via Internet Banking, bill payments made via AXS, interest, late payment charges, goods and services taxes, cash advances, balance transfers and other fees and charges shall not be taken into account in the award and computation of OCBC\$.
