



Terms and Conditions Governing Grab S\$5 off Promotion (the “Promotion”)

“You” refers to the customer.

“We/us/our” refers to OCBC.

Eligibility

- 1) The Promotion is limited to the first 5,000 bookings made with the Promotion Code (“**Promo Code**”) through the Grab app during each qualifying period stated below (each, a “**Qualifying Period**”):

19 July 2017 (6am) to 25 July 2017 (11:59pm), Singapore Time and
26 July 2017 (6am) to 31 July 2017 (11:59pm), Singapore Time.

- 2) By way of inputting the **Promo Code**, you agree to register for and accept the terms and conditions of the Promotion.
- 3) Subject to Clause 1, you are eligible to enjoy S\$5 off on a maximum of 5 Eligible Grab rides (as defined in Clause 4) during each Qualifying Period if you:

- hold a Singapore-issued OCBC principal Credit or Debit Card which is in good standing (“**Card**”) (Private Label Cards do not qualify);

and

- made the Eligible Grab ride with your Card (only) as the payment method in GrabPay with the following steps below during a Qualifying Period

HOW IT WORKS

Step 1:

Launch the Grab app and select GrabPay at the menu button on the top left corner. Add your Card as your payment method.

Step 2:

Return to the main screen and set the pick-up and drop-off locations.

Step 3:

Key in the Promo Code and ensure that your Card is selected for payment before confirming your booking. You will enjoy S\$5 off your fare when the ride is completed.

- 4) Eligible Grab rides are:
 - JustGrab
 - GrabShare
 - Standard Taxi
 - GrabCar
 - GrabFamily
 - Electric Taxi

- GrabCar (Premium)
 - Limo Taxi
- (Exclude GrabHitch and GrabShuttle)

- 5) In the event that the payment for the Eligible Grab ride is less than S\$5 (the “**Relevant Lesser Amount**”), you will only be entitled to receive a discount of up to the Relevant Lesser Amount. For instance, if the transaction is only S\$2, you will only be entitled to receive a discount of S\$2. The Promo Code would be treated as redeemed.

Usage of Promo Code

- 6) Promo Code is limited to the first 5,000 Grab bookings during each of the Qualifying Periods below:
- 19 July 2017 (6am) to 25 July 2017 (11:59pm), Singapore Time and
26 July 2017 (6am) to 31 July 2017 (11:59pm), Singapore Time.
- 7) A total of 10,000 bookings are eligible for the S\$5 off Eligible Grab rides subject to these terms and conditions.
- 8) Promo Code is limited to **five** redemptions per OCBC Cardmember and to be used for Eligible Grab rides in Singapore only.
- 9) Promo Code is available on the Grab App during each Qualifying Period on a “first-come, first-served” and “while stocks last” basis.
- 10) Successful utilization of the Promo Code means that S\$5 will be deducted from the final fare accordingly after the ride has been completed. S\$5 is deducted off the billed amount excluding prevailing GST and booking fee where applicable.
- 11) We are not responsible for the failure in acceptance and/or processing of such transactions by the merchant including but not limited to non-acceptance of Visa/MasterCard payments due to any issues such as network issue.
- 12) Once used, Promo Code will not be replaced under any circumstances whether during or after any Qualifying Period.
- 13) In the event that Grab booking is cancelled before the start of the ride, Promo Code will not be counted as redeemed.

General

- 14) We are not responsible for any failure or delay in the transmission or posting of such transactions by any party including but not limited to acquiring banks, merchant establishments, or any telecommunication provider.
- 15) We have the right to end this Promotion or change any terms and conditions at any time without giving you notice. This includes changing the terms and conditions of this Promotion, and/or rules relating to who is eligible for the Promotion and the Qualifying Period.
- 16) You allow us to reveal information about you or your account to any person (including the relevant taxi operators and/or the people involved in organising, promoting and carrying out the Promotion) (the “Relevant Third Parties”) as we see fit. You further acknowledge that you are aware that your personal information/data (“Data”) may be transferred and/or disclosed by us to the Relevant Third Parties for the purpose in connection with this Promotion (the “Purpose”). Without prejudice to such other rights we may have, you agree and consent to us and the Relevant Third Parties collecting, using and disclosing your Data for any purposes (including without limitation, you agree and consent to your Data being transferred by us to the Relevant Third Parties for the Purpose).
- 17) Our decision on all matters relating to this Promotion will be final and binding on all participants. If there is any difference between these terms and conditions and any brochure, marketing or promotional

material relating to the Promotion, these terms and conditions will prevail.

- 18) The laws of Singapore apply to these terms and conditions, and any disputes between you and us will be dealt with in the courts of Singapore. A person who is not a party to any agreement governed by these terms and conditions do not have any right under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any of these terms and conditions.
