Terms and Conditions Governing OCBC YES! Debit Card New Sign-Up Promotion 2017 (the "Promotion")

Promotion Period

1. The Promotion Period is from 25 July 2017 to 31 August 2017 (both dates inclusive) or such other period as may be determined by Oversea-Chinese Banking Corporation Limited ("OCBC") in its absolute discretion.

General
