## MasterCard World & World Elite Cardholders Terms & Conditions

## Conditions of play

- MasterCard Regional Golf is valid from 16<sup>th</sup> June 2016 to 15<sup>th</sup> June 2018.
- This Program is applicable to Principal World Elite & World MasterCard cardholders whose Card account is in good standing and regularised (not in default or not cancelled for whatever reason), from Singapore, Malaysia, Indonesia, Thailand, Vietnam and Philippines. This program is not transferable.
- Principal MasterCard World Elite cardholders enjoy complimentary green fee at 16 golf clubs in 6 countries on weekdays and weekends subject to availability.
- Principal MasterCard World cardholders enjoy 50% off walk-in green fee at 16 golf clubs in 6 countries on weekdays and weekends subject to availability.
- There is a maximum of 1 booking per cardholder per month and a maximum of 4 bookings per cardholder per annum.
- The SEA Golf Platform has available a maximum of 10 rounds per month per market for all MasterCard World Elite cardholders and a maximum of 10 rounds per month per market for all MasterCard World cardholders. For any interest on acquiring additional rounds of golf, please contact your Account Manager.
- Singapore clubs are valid on weekdays only.
- There is no paying guest requirement.
- There is a minimum of 2 golfers per flight on weekdays and 3 golfers per flight on weekends (subject to pairing and individual club's minimum golfer requirement per flight for booking).
- Weekday bookings must be done at least 4 working days in advance.
- Weekend bookings must be done at least 6 working days in advance.
- Acceptance of all golf bookings/changes to tee times will be at the discretion of the clubs and are subject to availability.
- Cardholder cannot make a golf booking directly at golf club.
- Privileges are not valid for use in conjunction with other non-MasterCard promotions, discounts or offers.
- Bookings may not be made more than 1 month from the date of play; and Cardholders are not allowed to book for the next golf game until the current game is played.
- Golf Privilege cannot be used with other promotion, participation in social games or golf tournament.
- Cardholder / Club Member cannot make a booking directly at the club and transfer the confirmed tee time over to the MasterCard Cardholder.
- The concierge will not process bookings for Club Members with the golf club; Club Member must liaise with the club directly to be paired in the same flight as a Cardholder.
- Confirmation of tee-times will be provided 1 week prior to date of play for all clubs.
- Confirmation of tee-times will be provided 1 week prior to date of play for Malaysia, Indonesia, Thailand, Philippines & Vietnam unless exceptionally requested by golfer, whereby confirmation may be provided up to 2 weeks prior to date of play, based on individual club's tee-time release schedule.
- Additional Golf rates quoted are to be borne by the Cardholder and his/her guest(s) & must be charged onto the MasterCard credit card of booking upon confirmation.
- Cardholders and guests have to pay for buggy, caddie, turfmate, locker fee and insurance at normal published rates at the club where applicable, which is to be charged onto the MasterCard credit card of booking upon confirmation or at the golf club.

- Cancellation and amendment fees apply.
- Amendments can only be made for bookings that are not within the cancellation period (for change of date-of-play that falls within cancellation period, it will be considered as a cancellation and processed as a new booking).
- There will be no rain check.
- There is an amendment fee of SGD20 (or equivalent of local currency of play) for any changes made to the confirmed golf booking such as amendments to tee-times and change of date of play / change of players' names.
- Cancellation fees will be charged directly to the Cardholder's credit card account.
- Golfers must have a valid handicap.
- The MasterCard golf program is valid for golf rounds only. MasterCard Cardholders and their guests will not have access to the other recreational facilities at the golf club.
- The MasterCard golf program is not to be regarded as a golf club membership.
- To the fullest extent permissible by law, each participating MasterCard Cardholder releases MasterCard/GC/the respective golf clubs from any claim, loss, damage, cost or expense (including any claim for legal expenses) sustained or incurred by him/her in connection with their participation in the MasterCard golf program.
