

## **Terms and Conditions Governing Esso x FairPrice Cross Promotion 2017**

1. The Promotions (as defined below) are valid for all OCBC Bank Credit / Debit Cards except private label cards\* (each an “OCBC Card” and collectively, the “OCBC Cards”) from 8 June 2017 to 12 July 2017.

\*Private Label Cards refer to in-store credit or charge cards issued by a retailer, and not by OCBC.

2. “OCBC” refers to Oversea-Chinese Banking Corporation Limited, “Esso” refers to ExxonMobil Asia Pacific Pte Ltd and “FairPrice” refers to NTUC Fairprice Co-operative Ltd.
3. “FairPrice Stores” refers to FairPrice Supermarket, FairPrice Xtra and FairPrice Finest stores.

### **4. The Promotions:**

#### **3.1 Promotion 1: S\$2 Esso Fuel Voucher**

- a) With every S\$50 spent in a single receipt and charged to an OCBC Card at FairPrice Stores , customers holding OCBC Cards (“OCBC Cardholders”) are entitled to an S\$2 fuel voucher for use at Esso service stations (“Esso Fuel Voucher”).
- b) With every S\$50 gross fuel spend at Esso service stations, OCBC Cardmembers will be entitled to redeem one Esso Fuel Voucher. Payment for the fuel spend must be made with an OCBC Card. Multiple redemptions in a single transaction is allowed.
- c) OCBC Cardholders must present the Esso Fuel Voucher at the cashier’s counter in Esso service stations. Upon redemption, the Esso Fuel Voucher will be retained by Esso.
- d) This Promotion is not applicable in conjunction with other promotions, vouchers or any special discounts unless otherwise stated.
- e) The Esso Fuel Voucher cannot be used with any Esso Fleet Card, Smiles Taxi Card, Speedpass or outdoor payment.

#### **3.2 Promotion 2: \$2 FairPrice Voucher**

- a) With every S\$50 gross fuel spend charged to an OCBC Card at Esso service stations, OCBC Cardholders are entitled to a S\$2 voucher for use at FairPrice Stores (“FairPrice Voucher”). Not applicable to purchases made at FairPrice Xpress.
- b) OCBC Cardholders who transact via Speedpass or outdoor payment at Esso service stations will need to collect the FairPrice Voucher from the cashier’s counter with their receipt as proof of purchase.
- f) With every S\$50 grocery spend at FairPrice Stores, OCBC Cardholders will be entitled to redeem one FairPrice Voucher. Payment for the grocery spend must be made with an OCBC Card. Not for purchase of cigarettes, statutory products and FairPrice Gift Vouchers. Multiple redemptions in a single transaction is allowed.
- g) OCBC Cardholders must present the FairPrice Voucher at the cashier’s counter for redemption. Upon redemption, the FairPrice Voucher will be retained by FairPrice.
- h) This promotion is not applicable in conjunction with other promotions, vouchers or any special discounts unless otherwise stated.

### **Miscellaneous**

5. Promotion 1 and Promotion 2 (collectively “Promotions”) apply to Visa or Mastercard transactions made with an OCBC Card. NETS and cash transactions are not eligible for the Promotions. The FairPrice Voucher and Esso Fuel Voucher must be redeemed by 26 July 2017.
5. The decision of OCBC, FairPrice and Esso on all matters relating to the Promotions is final, conclusive and binding on all participants and no correspondence will be entertained.
6. In the event of any inconsistency between these terms and conditions and the contents of any brochure, marketing or promotional material relating to the Promotions, these terms and conditions shall prevail.
7. OCBC, FairPrice and Esso reserve the right to terminate or suspend any of the Promotions and/or add to, delete, change or vary these terms and conditions at any time or from time to time without notice.
8. These terms and conditions shall be governed by the laws of Singapore and the participants shall irrevocably submit to the non-exclusive jurisdiction of the courts of Singapore. A person who is not a party to any agreement governed by these terms and conditions shall have no rights under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any of these terms and conditions.
