(each, an “**Authorised Action**” and collectively, the “**Authorised Actions**”).

4. The Primary Organisation:

- (a) agrees to, and accepts, the authority given to it by each Secondary Organisation as set out in this letter; and
- (b) agrees and confirms that the persons authorised to perform any Authorised Action for the Primary Organisation on behalf of each Secondary Organisation shall be the same persons so authorised in accordance with the most recent mandate provided by the Primary Organisation to OCBC from time to time in respect of Primary Organisation’s own bank accounts with OCBC.

5. Each of the Primary Organisation and the Secondary Organisations confirms that the authority set out in this letter shall continue in full force and effect unless OCBC has been notified in writing of the revocation of such authority and powers by an authorised person of the Primary Organisation and the Secondary Organisations.
