If you have provided a third party's personal data to us, you acknowledge that you have obtained their consent to provide their personal data to OCBC for the same Purposes.

Any replies provided by the OCBC Cognitive Agent, including any general services, products, information, data, text, graphics, audio, video, links or other items, are provided for information purposes only. All services are provided "as is" and "as available". No representation or warranty whatsoever (including any representation or warranty as to accuracy, usefulness, adequacy, timeliness or completeness) in respect of any information (including without limitation any statement, figures, opinion, view or estimate) provided by the OCBC Cognitive Agent is given by OCBC and it should not be relied upon as such. Neither OCBC nor the OCBC Cognitive Agent undertakes an obligation to update the information or to correct any inaccuracy that may become apparent at a later time. All information and services provided are subject to change without notice.
