Market Commentary

- The SGD swap curve bear steepened yesterday, with shorter tenors trading 2-4bps higher, belly tenors trading 5bps higher while longer tenors traded 5-6bps higher.
- The Bloomberg Barclays Asia USD IG Bond Index average OAS remained mostly unchanged at 150bps, and the Bloomberg Barclays Asia USD HY Bond Index average OAS widened 5bps to 678bps. The HY-IG Index Spread widened 5bps to 528bps.
- There were very minimal flows in SGD corporates on Monday.
- 10Y UST fell 2bps to 1.13% on the back of rising coronavirus cases and a push for a second impeachment against President Trump.

- Enrong International (Hongkong) Ltd. (Guarantor: Changzhou Eastern New City Construction Group Co.) priced a USD300mn 3-year bond at 3.1%, tightening from IPT of 3.7% area.
- China Cinda 2020 I Management Ltd (Guarantor: China Cinda HK Holdings Co Ltd) priced a USD500mn 3-year bond at T+115bps, tightening from IPT of T+150bps area, a USD300mn 5-year bond at T+140bps, tightening from IPT of T+175bps area, a USD400mn 7-year bond at T+185bps, tightening from IPT of T+215bps area, and a USD800mn 10-year bond at T+195bps, tightening from IPT of T+230bps area.
