OCBC BANK PRICED US\$750,000,000 OF TIER 2 SUBORDINATED NOTES

Oversea-Chinese Banking Corporation Limited ("OCBC Bank") has priced US\$750,000,000 of fixed rate subordinated notes ("Notes") under its US\$30 billion Global Medium Term Note Program ("Program"). The net proceeds from the issue of the Notes will be used for general corporate purposes of OCBC Bank. The Notes are expected to qualify as Tier 2 capital of OCBC Bank under the requirements of the Monetary Authority of Singapore ("MAS").

The Notes are priced at 100%, and will bear a coupon of 4.602% per annum from the issue date to the call date on 15 June 2027 ("Call Date"). If the Notes are not redeemed, the interest rate from the Call Date to the maturity date on 15 June 2032 will be reset to a fixed rate per annum equal to the aggregate of the then-prevailing 5-year U.S. Treasury Rate and 1.575%. As a Basel III capital instrument, if OCBC Bank is determined by the MAS to be non-viable, the Notes will be written off in whole or in part. In addition, the Notes may be subject to cancellation, modification, conversion, change in form, or have the effect as if a right of modification, conversion, or change of form had been exercised by the MAS in the exercise of the MAS's powers under Division 4A of Part IVB of the Monetary Authority of Singapore Act 1970 of Singapore without prior notice.

Barclays Bank PLC, Singapore Branch, Citigroup Global Markets Singapore Pte. Ltd., J.P. Morgan Securities Asia Private Limited and OCBC Bank acted as Joint Lead Managers and Joint Bookrunners for this issue.

The Notes are expected to be rated A2 by Moody's Investors Service, BBB+ by Standard & Poors and A by Fitch Ratings Ltd, and issued on 15 June 2022. Application will be made for the listing of the Notes on the Singapore Exchange Securities Trading Limited (the "SGX-ST"). The SGX-ST assumes no responsibility for the correctness of any of the statements made or opinions or reports contained herein. Admission of the Notes to the Official List of the SGX-ST is not to be taken as an indication of the merits of OCBC Bank, the Program or the Notes.
