OCBC PRICED GBP 1 BILLION FLOATING RATE COVERED BONDS DUE 2029

Oversea-Chinese Banking Corporation Limited (“**OCBC**”) has priced GBP 1 billion in aggregate principal amount of floating rate covered bonds due 2029 (“**Covered Bonds**”) under its US\$10 billion Global Covered Bond Programme (“**Programme**”). The net proceeds from the issue of the Covered Bonds will be used for the general corporate purposes of OCBC.

The Covered Bonds will bear interest at the Compounded Daily SONIA benchmark plus 0.48% per annum payable quarterly in arrear. The Covered Bonds are expected to be rated Aaa by Moody’s Investors Services Limited and AAA by Fitch Ratings Ltd., and will be guaranteed as to payments of interest and principal by Red Sail Pte. Ltd. (“**Red Sail**”). The guarantee (the “**Covered Bond Guarantee**”) will be secured by a portfolio of assets purchased by Red Sail from OCBC. The Covered Bonds are expected to be issued on 26 August 2026.

Barclays Bank PLC, Lloyds Bank Corporate Markets plc, RBC Europe Limited, Oversea-Chinese Banking Corporation Limited, The Hongkong and Shanghai Banking Corporation, Singapore Branch and The Toronto-Dominion Bank acted as the joint lead managers for this issue.

An application will be made for the listing of the Covered Bonds on the Singapore Exchange Securities Trading Limited (“**SGX-ST**”) and the Covered Bonds are expected to be listed on the SGX-ST on 27 August 2026. The SGX-ST assumes no responsibility for the correctness of any of the statements made or opinions or reports contained herein. Admission of the Covered Bonds to the Official List of the SGX-ST is not to be taken as an indication of the merits of OCBC, the Programme or the Covered Bonds.
