# Terms and Conditions Governing OCBC 360 Account and Kids Account Promotion 2025

#### V01052025

The OCBC 360 Account and Kids Account Promotion 2025 (the "**Promotion**") commences from 1 May 2025 and ends on 31 July 2025 (or any such date(s) as may be determined and notified by OCBC Bank in its sole discretion) ("**Promotion Period**").

Terms and Conditions Governing the OCBC 360 Account and Kids Account Promotion 2025 are to be read in conjunction with the Terms and Conditions governing the 360 Account found on OCBC website > Personal Banking > Account > 360 Account and refer to Terms and conditions governing the 360 Account, OCBC MyOwn Account found on OCBC website > Personal Banking > Account > OCBC MyOwn Account and Terms and Conditions Governing OCBC Child Development Accounts (Baby Bonus) found on OCBC website > Personal Banking > Account > OCBC Child Development Accounts (Baby Bonus).

# 1. Eligibility

- 1.1 The Promotion is open to individuals:
  - a) whose child opens a new OCBC MyOwn Account or is holding an OCBC MyOwn Account; or
  - b) opens a new OCBC Child Development as a trustee or is a trustee of an OCBC Child Development Account; and
  - c) opens a new 360 Account or is holding a 360 Account

collectively, the "Eligible Customer".

### 2. Promotion Mechanics

### **Bonus Interest**

2.1 An Eligible Customer shall be eligible to receive the following Bonus Interest for the months of May, June and July 2025, upon satisfaction of the criteria set out in clauses 1 and 2:

- 2.2 The Family Bonus Interest will be credited to the Eligible Customer's 360 Account on the 15<sup>th</sup> working day of the following month after meeting the criteria set out in clauses 1 and 2.
- 2.3 Each Eligible Customer will only be accorded 1 Family Bonus Interest to the 360 Account where they are the Primary account holder.
- 2.4 The Family Bonus Interest is only awarded to Eligible Customers for months where the criteria set out in 2.1 has been met. In months in which Eligible Customers do not meet the criteria, no Family Bonus Interest will be credited.
- 2.5 If the 360 Account is closed before the crediting of the Family Bonus Interest, the Family Bonus Interest will be forfeited.
- 2.6 Please refer to the tables below which illustrates how this Promotion works.
