## TERMS AND CONDITIONS GOVERNING BALANCE TRANSFER ONLINE PROMOTION

- 1. This Balance Transfer Online Promotion is open only to those ("Eligible Account Holder"):
- (a) who hold an EasiCredit account and/or Credit Card account(s) with Oversea-Chinese Banking Corporation Limited ("OCBC");
