



Terms and Conditions Governing STACK X Great Eastern Rewards 2021 Sign-up Campaign ("Promotion")

Promotion Period

1. The promotion period runs from 11 March 2021 Singapore Time (SGT) 00:00 till 15 October 2021 SGT 23:59 (both dates inclusive), or such other period(s) as may be determined by Oversea-Chinese Banking Corporation Limited ("OCBC Bank") in its absolute discretion ("**Promotion Period**").

Eligibility

2. For the STACK X Great Eastern Rewards 2021 sign-up campaign (the "**STACK Campaign**"), you are eligible to receive 500 GREAT Dollars ("**Reward**") if:
 - a. You are not an existing STACK member;
 - b. You are among the first 4,000 to sign up for a STACK membership via the stackreward.com website with promo code "UGSTACK01" during the Promotion Period;
 - c. Sign up STACK with the same email address registered with Great Eastern Rewards; and
 - d. Added your Great Eastern Rewards account to STACK.
