

Terms and Conditions pertaining to the NTUC/OCBC Plus! Visa Card Caltex Fuel Discount Promotion (the "Promotion")

1. This Promotion is valid from 01 March 2020 to 31 December 2020 (both dates inclusive) (the "Promotion Period").

Eligibility

 "Eligible Cardmember" refers to any existing active NTUC/OCBC Plus! Visa Credit/Debit Cardmember who makes fuel purchases at Caltex Stations during the Promotion Period.

Promotion

- **3.** Eligible Cardmembers will receive up to 20% fuel savings during the Promotion Period for all grades of petrol and diesel at Caltex. The fuel savings is inclusive of:
 - a. 18% instant fuel discount 5% site discount and 13% NTUC/OCBC Plus!
 Visa Credit/Debit Card ("Plus! Visa Card") discount;
 - b. A cash rebate of S\$7 with a minimum of S\$300 nett fuel purchase per month (equivalent to 1.8% additional rebate on gross fuel purchase); and
 - c. 0.2% LinkPoints on nett fuel purchase for every S\$1 charged to the Plus! Visa
 Card (equivalent to 0.16% rebate on gross fuel purchase).
- 4. In addition, every litre of fuel purchased with the Plus! Visa Card at Caltex earns the Eligible Cardmember 3 LinkPoints under the Plus! Programme. 150 LinkPoints is equivalent to S\$1.00. Terms and conditions for LinkPoints issuance at Caltex apply. For more information, visit www.caltex.com/sg-plus.
- **5.** Payment must be made indoors and charged to a Plus! Visa Card. Cash and NETS payments are not eligible for the Promotion.
