# Terms & Conditions for OCBC 90°N Visa Card Launch Contest ("Contest") & Voting Campaign ("Voting")

 These are the Terms and Conditions of the Contest organised by Oversea-Chinese Banking Corporation Limited ("we", "us", "our" or "OCBC Bank"). The act of the participants making a Submission (defined below) in this Contest constitutes to acceptance of these Terms and Conditions.

## Eligibility, Contest Period and Voting Period

- 2. The Contest shall run from 17 November 2021 00:01 Singapore Time (SGT) to 31 January 2022 23:59 SGT (both dates inclusive), or such other periods(s) as may be determined by us at our absolute discretion (the "**Contest Period**").
- 3. The voting shall run from 21 January 2022 00:01 Singapore Time (SGT) to 31 January 2022 23:59 SGT (both dates inclusive), or such other period(s) as may be determined by us at our absolute discretion (the "**Voting Period**").
- 4. You will be eligible to participate in the Contest if you have a valid and public Facebook or Instagram account (each an "Eligible Participant").

### **Contest & Voting Rules**

- 5. To qualify for a chance to win a Prize, Eligible Participants must be an OCBC 90°N Visa Cardmember before the end of the Contest Period, upload an original photo of a landmark or destination made up of daily everyday objects as a Facebook post or Instagram post via their public Facebook or Instagram account (each a "**Submission**"). All Submissions must contain the hashtag "#Wanderlust90N".
- 6. Eligible Participants are required to remain eligible (in accordance with the eligibility requirements set out in these terms and conditions) and to keep their Submissions live until the selection of the entries for the next voting phase is completed.
- 7. Each Eligible Participant may submit multiple Submissions. However, Submissions with repeated and/or plagiarised content and/or ideas/captions will be deemed invalid. OCBC Bank shall be entitled to deem at its sole and absolute discretion whether any Submission is valid or not.
- 8. Any Submission made, posted or submitted after the Contest Period has ended will not be entertained.
- 9. Top 5 Submissions with the most number of likes and Top 5 Submissions with the most number of unique comments will be consolidated on our campaign page for Voting to commence.
- 10. During the Voting Period, anyone is able to vote for a Submission but votes will be counted twice if the voter is an OCBC 90°N Visa Cardmember.
- 11. Voters with OCBC 90°N Visa Card will be asked to submit the below details for verification when voting on the campaign page:
  - a) Name as per in NRIC
  - b) Last 4 digits of NRIC
  - c) Last 8 digits of the OCBC 90°N Visa card number

### Submission Restrictions and Ownership of Submissions

- 12. All Submissions posted shall become the sole and exclusive property of OCBC Bank. OCBC Bank shall own and have the sole and exclusive right to use, copy, distribute, translate, modify, display and prepare derivative works of any Submission, as well as the right to authorize uses of any Submission by any other party. OCBC Bank shall have the right to obtain and to hold in its own name, copyrights, registrations or other such protection as may be appropriate, and any extensions and renewals thereof. Participants shall, if requested by OCBC Bank, assign all intellectual property rights to OCBC Bank on OCBC Bank's terms, and shall take such steps as may be reasonably required by OCBC Bank to perfect such assignment, including without limitation executing such documents as may be reasonably required by OCBC Bank and/or to do all such things necessary to perfect and effect the assignment, and any cost incurred thereof shall be borne by the participant.
- 13. OCBC Bank will not be held liable for any copying, re-posting, reproduction, publication and/or use of the Submissions, and/or any of the contents therein, whether by OCBC Bank or any third party.
- 14. OCBC Bank shall have the right to disqualify and remove such Submissions at its sole discretion without informing the participant.

Information provided to OCBC Bank will be used solely for the purpose of eligibility verification and Prize (defined below) fulfilment by OCBC Bank and Eligible Participants who are awarded a Prize (defined below) consent to OCBC Bank disclosure of their details to, and the collection and use of their details by ETIHAD AIRWAYS PJSC for purposes of Prize (defined below) fulfilment.

18. The Prizes will be given to the respective Winners within 2 months from OCBC Bank's receipt of the Winner's details and information on the preferred flight dates.



- 19. Subject to the availability of flights, Winners can schedule their preferred flight date anytime before 31 December 2022.
- 20. In the event that a Winner is subsequently disqualified, or fails to accept or collect his or her Prize, OCBC Bank reserves the right to select reserve Winner(s) to replace that Winner.
- 21. All Prizes are non-transferrable, non-assignable, non-exchangeable, and not saleable for cash, credits or in-kind. OCBC Bank shall have the right to replace or substitute the Prizes with an item of similar value.
- 22. The carrier of the flight tickets is Etihad Airways.
- 23. No lounge access for economy class tickets. Business class ticket lounge access is subject to availability. Any excess baggage to be borne by the Winners.
