

# TERMS AND CONDITIONS GOVERNING OCBC VOYAGE CARD SERIES AND PREMIER VISA INFINITE LUXURY SPEND PROMOTION (the "Promotion")

## Promotion Period

• The promotion period shall run from 18 January 2024 Singapore Time (SGT) 00:00 to 29 February 2024 SGT 23:59 (both dates inclusive), or such other periods(s) as may be determined by Oversea-Chinese Banking Corporation Limited ("OCBC Bank") at its absolute discretion (the "Promotion Period").

## Eligibility

- You will qualify for the Promotion ("Eligible Cardmember") if:
  - You hold an Eligible Card;
  - You have successfully registered your interest in the Promotion by sending an SMS to 72377. You must use the mobile number that is in our records;
  - You have spent a minimum of S\$10,000 equivalent in Qualifying Spend (as defined below), on selected merchants and/or categories as outlined under promotion mechanics, and are among the first 500 Eligible Cardmembers within the Promotion Period; and
  - Your Eligible Card account is active and in good standing with OCBC Bank from the start of the Promotion Period until 6 months after the end of the Promotion Period.

#### Definitions

  - OCBC Premier VOYAGE Card

vi. will be determined by its transaction date based on Singapore Timing (UTC+08:00). For avoidance of doubt, the date on which the transaction is submitted or posted may differ from the actual date the transaction was made and OCBC Bank bears no liability for any late submission or transaction posting of any purchase by any merchant that might affect the Promotion.

## **Promotion Mechanics**

- Eligible Cardmember who meet the conditions specified herein will receive 30,000 VOYAGE Miles or 80,000 OCBC\$, subject to these terms and conditions.

- The Gift is awarded on top of the OCBC\$ that you can enjoy under the Premier VISA Infinite Credit Card Programme, available at OCBC website > Personal Banking > Cards > Premier VISA Infinite Credit Card > Terms and Conditions Governing the OCBC Premier Visa Infinite Credit Card (with effect from 1 February 2023)
