

# Terms & Conditions Governing the 'OCBC x FairPrice Christmas 2021 Campaign' (the "Promotion")

#### **Promotion Period**

1. The promotion period shall run from 23 December 2021 to 27 December 2021 (both dates inclusive), or such other period(s) as may be determined by Oversea-Chinese Banking Corporation Limited ("OCBC Bank") at its absolute discretion (the "Promotion Period").

## Eligibility

- 2. You will qualify for the Promotion ("Eligible Cardmember") if:
  - i. You are an existing OCBC Credit/Debit Cardmember;
  - ii. Your OCBC Credit/Debit Card account(s) are active and in good standing with OCBC Bank during the Promotion Period; and
  - iii. You have made a Qualifying Spend (as defined below) during the Promotion Period with your Eligible Card (defined below) in accordance with the terms and conditions.

#### **Definitions**

- 3. "Eligible Cards" means any existing OCBC Credit/ Debit Cards.
- 4. "Qualifying Spend" refers to a minimum spend of \$\$60.00 in a single transaction at FairPrice Supermarket, FairPrice Finest, FairPrice Xtra, Warehouse Club and Unity stores (excluding Cheers, FairPrice Xpress and FairPrice Online) ("FairPrice"), on any FairPrice products except the purchase of cigarettes, newspapers, magazines, 4D, Toto, Singapore Sweep, Gift Card, FairPrice Gift Vouchers, infant milk powder (0-12 months), prescriptions and pharmacy only medicines, during the Promotion Period. For the avoidance of doubt, Scan & Go and Pay Via FairPrice App transactions at the eligible FairPrice stores are eligible for the Promotion.
- 5. For the avoidance of doubt, OCBC Bank has the absolute discretion to determine whether a transaction is considered a "Qualifying Spend".

## Return Voucher

- 6. Eligible Cardmembers who meet the requirements specified in these terms and conditions will receive a \$\$6.00 FairPrice Voucher ("Return Voucher"), subject to these terms and conditions. For purchases made on Scan & Go, Eligible Cardmembers will receive the return voucher with an equivalent value in the form of a Promo Code (the "Return Promo Code").
- 7. The Promotion is limited to the first 80,000 qualifying transactions made by Eligible Cardmembers who meet the requirements set out in these terms and conditions during the Promotion Period. For the avoidance of doubt, in the event that any person entitled to the Return Voucher is subsequently found to be ineligible for the Promotion, OCBC Bank shall not be obligated or liable to provide the Return Voucher to another Eligible Cardmember.
- 8. Eligible Cardmembers are entitled to a maximum of one (1) Return Voucher or (1) Return Promo Code (for purchases made on Scan & Go) per day upon making a Qualifying Spend in accordance with these terms and conditions during the Promotion Period.
- 9. Only one Eligible Card can be used per day to receive the Return Voucher or Return Promo Code.
- 10. Each Return Voucher or Return Promo Code entitles the cardmember to \$\$6.00 off at all FairPrice, FairPrice Finest, FairPrice Xtra, Warehouse Club and Unity stores when the customer spends a minimum of \$\$40.00 in a single transaction and charges the remaining amount to be paid for to their OCBC Card.
- 11. Each Return Voucher and Return Promo Code is valid for use from 30 December 2021 to 5 January 2022.



- 12. Only one original Return Voucher or Return Promo Code can be used per transaction.
- 13. For purchases on Scan & Go, the \$\$6.00 Return Promo Code will be deposited into the Eligible Cardmember's e-wallet on the FairPrice App by 30 December 2021. To utilise the Return Promo Code, customers must apply the promo code with minimum \$40 in their Scan & Go cart before checking out.
- 14. No splitting of receipts allowed. The Return Voucher and Return Promo Code is not valid for purchase of cigarettes, newspapers, magazines, 4D, Toto, Singapore Sweep, Gift Card, FairPrice Gift Vouchers, infant milk powder (0-12 months), prescription and pharmacy only medicines and not exchangeable for cash, FairPrice Gift Vouchers, FairPrice Gift Cards, FairPrice Loyalty Redemption Point accumulation and/or other similar goods and services.
- 15. The Return Voucher cannot be combined or used in conjunction with any other discount voucher or other Return Voucher(s). For purchases on Scan & Go, the Return Promo Code cannot be used with any other available promo codes or other Return Promo Code(s). Any unutilized balance on a Return Voucher or Return Promo Code will be forfeited and will not be refunded to the customer. There is no draw-down function on the Return Voucher or Return Promo Code.
- 16. The Return Voucher is non-refundable and/or non-exchangeable/replaceable in the event of loss, theft, or damage.
- 17. The Return Voucher is for one-time use only and must be presented to and retained by the cashier at checkout.
- 18. The Return Voucher and Return Promo Code are not renewable upon expiry. Expiry date is final.
- 19. OCBC Bank reserves the right in its sole and absolute discretion to determine whether a transaction qualifies as a Qualifying Spend under the Promotion. If OCBC Bank in its sole and absolute discretion decides that any transaction is not considered a valid transaction, the Return Voucher and/or Return Promo Code will not be awarded.
- 20. OCBC Bank reserves the right to claw-back and deduct from the Eligible Cardmember's account the equivalent value of the Return Voucher and/or the Return Promo Code if the Eligible Cardmember cancels, refunds or reverses any transaction made on the purchase of Qualifying Spend during the Promotion Period such that the Qualifying Spend is not met. Further, if any Eligible Cardmember is subsequently discovered to be ineligible to participate in the Promotion or to receive the Return Voucher and/or Return Promo Code (which eligibility shall be determined at the discretion of OCBC Bank), OCBC Bank reserves the right to (i) withdraw the Return Voucher and/or Return Promo Code at any time; or (ii) claw-back the Return Voucher and/or Return Promo Code or request the relevant customer to repay to or compensate OCBC Bank the value of the Return Voucher and/or Return Promo Code at any time, and OCBC Bank shall have the right to debit the value of the Return Voucher and/or Return Promo Code or such other amount as it deems fit from the account(s) of the customer. No person shall be entitled to any payment or compensation from OCBC Bank should any Return Voucher and/or Return Promo Code be withdrawn, if any Return Voucher and/or Return Promo Code is reclaimed by OCBC Bank, or if a customer is asked to repay to or compensate OCBC Bank the value of the Return Voucher and/or Return Promo Code for whatsoever reasons.

### General

21. The eligibility of any Eligible Cardmember to receive the Return Voucher and/or Return Promo Code shall be determined at the absolute discretion of OCBC Bank.



- 22. OCBC Bank reserves the right at its absolute discretion to terminate the Promotion or vary, delete or add to any of these terms and conditions at any time without notice including without limitation, the eligibility of any cardholder and the dates of the Promotion.
- 23. OCBC Bank shall not be responsible for the quality, merchantability or fitness for any purpose or any other aspect of the Promotion, or any product and/or service relating to the Promotion. Notwithstanding anything herein, OCBC Bank not at any time shall not be responsible or held liable for any defect or malfunction in any product or the deficiency in any service provided, and/or any loss, injury, damage or harm suffered or incurred by or in connection with the Promotion, and/or the use of any product and/or service relating to the Promotion, by any person.
- 24. OCBC Bank's decisions on all matters relating to the Promotion shall be final and binding on all participants. No correspondence or appeal shall be entertained by OCBC Bank. In the event of any inconsistency between these terms and conditions and any brochure, marketing or promotional material relating to the Promotion, these terms and conditions shall prevail.
- 25. OCBC Bank shall not be responsible for any loss or damage to any person in connection with the Promotion howsoever arising, including any error in computing chances, any breakdown or malfunction in any computer system or equipment, or any notice which is misdirected or lost in the post or in transmission.
- 26. These terms and conditions shall be governed by the laws of Singapore and each participant in the Promotion irrevocably submits to the non-exclusive jurisdiction of the courts of Singapore. A person who is not a party to any agreement governed by these terms and conditions shall have no right under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any of these terms and conditions.
