



**Sembcorp Power OCBC New Sign Up Promotion Nov 2021 (“Promotion”) - Terms and Conditions**

1. These Terms and Conditions must be read in conjunction with [Sembcorp Power’s General Terms and Conditions \(Homes & Businesses\)](#), applicable Price Plan Summary, and other applicable Promotion Terms and Conditions.
2. The Promotion commences on 1 November 2021 and ends on 30 November 2021, both days inclusive (“Promotion Period”).
3. Only OCBC (“OCBC” or “Bank”) Cardmembers, who signed up for an electricity price plan (“Promo Price Plans”) with Sembcorp Power are eligible to participate in this Promotion (“Eligible Cardmember”). For avoidance of doubt, this promotion is not eligible for Renewal sign-ups.
4. Under the Promotion, Eligible Cardmember will receive the below bill rebates and vouchers (collectively as the “Gift”) if he/she fulfills all the following:
  - a. successfully sign up for a Promo Price Plan with Sembcorp Power;
  - b. input promo code during the sign-up process;
  - c. successfully sets up a recurring payment arrangement by 31 December 2021;
  - d. charges to his/her OCBC Card the full amount of their Sembcorp electricity bill on recurring; and
  - e. to have the first Recurring Payment successfully charged and posted to their OCBC card by 28 February 2022

5. The additional Rebate will be fulfilled by 31 March 2022. The Gift will be used to offset the electricity bill, excluding Security Deposit and all non-electricity usage related charges. If the electricity bill amounts to less than the value of the Rebate, the remaining value will be used to offset the subsequent electricity bill(s). An Eligible Cardmember who refunds, terminates or disputes the recurring bill arrangement or the new Sembcorp plan before he/she receives the Gift, will forfeit the Gift.
6. If any amount of the Gift is not utilized by any Eligible Cardmember, upon the expiry or termination of the Promo Price Plan, such unutilized Gift will be forfeited. The Gift shall under no circumstances whatsoever be paid out in cash or in kind to any party.

Sembcorp Power reserves the right to claim back the full sum of Gift given in cash from the Eligible Cardmember in the event that the Promo Price Plan is terminated before the contract ends for any reason that is no fault of Sembcorp Power, or the recurring payment arrangement is terminated within 12 months from the date the first recurring payment was charged to the OCBC Credit or Debit Card, or if the Sembcorp Bank Plan is terminated for any reason.
8. Save for existing credit card promotions, this Promotion is not valid with other promotions, special discounts, roadshow activations and MyRepublic stores, unless otherwise stated.
