

# Terms and Conditions governing the OCBC Titanium Rewards Card and STACK \$50 Grab Sign Up Promotion 2020 ("Promotion")

## **Promotion Period**

The Promotion Period is defined as the relevant calendar month in which you receive
the short message service ("SMS") or electronic direct mailer ("EDM") or such other
period as may be determined by Oversea-Chinese Banking Corporation Limited
("OCBC") in its absolute discretion ("Promotion Period").

# **Eligibility**

- 2. To qualify ("Qualified Cardmembers"), you must:
  - (a) be an existing OCBC credit/debit cardholder and have received an EDM or SMS from OCBC inviting you to participate in the Promotion;
  - (b) be amongst the first 2,000 applicants to successfully apply for an OCBC Titanium Rewards Card through the EDM or SMS that you received; and
  - (c) sign up for the STACK platform within the Promotion Period using the same name, date of birth, email address and mobile numbers as the OCBC Titanium Rewards Card application.
- 3. The invitation to participate in the Promotion is not transferrable.

- 4. Each Qualified Cardmember is entitled to receive \$50 Grab vouchers ("Sign Up Bonus").
- 5. Each Qualified Cardmember is entitled to receive a maximum of one Sign Up Bonus throughout the Promotion Period.
- 6. Qualified Cardmembers will be notified within 2 months after the Promotion Period via an SMS through the mobile number registered with their OCBC Titanium Rewards Card. The SMS will contain the code to redeem the Sign Up Bonus.
