

# Terms and conditions governing the STACK X Harry's Launch Campaign 2020 ("Promotion") – Fully redeemed

## **Promotion Period**

1. The promotion period shall run from 23 September 2020 till 6 October 2020 (both dates inclusive), or such other date(s) as may be determined by Oversea-Chinese Banking Corporation ("OCBC Bank") at its absolute discretion ("Promotion Period").

### Eligibility

- 2. You will qualify for the Promotion ("Eligible Customer") if:
  - (a) You are not an existing STACK member; and
  - (b) You are among the first 2,500 during the Promotion Period to sign up for your STACK account and add a valid Harry's Rewards Programme to this same STACK account.

### **Promotion Mechanics**

- 3. Each Eligible Customer will receive 80 Harry's points ("STACK Reward").
- 4. Each Eligible Customer will also receive a S\$20 off Harry's voucher valid with a minimum spend of \$50 ("Welcome Voucher").

### **STACK Reward (Harry's Rewards Points)**

- 8. Your Harry's Rewards Points will be valid for 12 months starting from the following month of which you earned them. E.g. Harry's Rewards Points earned on 21 September 2020 will expire on 30 September 2021.

- 10. OCBC Bank reserves the right to substitute the STACK Reward with another gift of a similar value without prior notice, should there be any unforeseen circumstances.

### Welcome Voucher



- 11. For voucher validity, please refer to the expiry date indicated on the voucher details page.
- 12. Voucher may be used for a single transaction only and must be presented before payment.

- 14. Valid for dine-in only at all outlets except for Changi T3.
- 15. Voucher can be redeemed with a minimum of S\$50 spent, excluding service charge and GST.
