

Terms and conditions governing the STACK Sign-Up \$5 Grab E-Voucher Rewards Campaign 2020 ("Promotion")

Promotion Period

1. The "Promotion Period" is defined as the period from 9 March 2020 till 3 May 2020, (both dates inclusive), or such other date(s) as may be determined by OCBC Bank in its sole and absolute discretion from time to time without prior notice ("Promotion Period").

Voucher

- 6. To use the Voucher, simply copy and paste the 'Voucher Number' as the promo code at the checkout page.
- 7. Voucher is applicable on Grab App (both iOS and Android) only.
- 8. Voucher is valid for all GrabCar and GrabTaxi, but not valid for GrabHitch and GrabShuttle.
- 9. Voucher cannot be combined with other promo codes.
- 10. Voucher may be used for a single transaction only.
- 11. Voucher code must be entered before payment.
