

Terms and Conditions governing the OCBC Titanium Rewards and OCBC Titanium Card JC Concert Campaign (the "Promotion")

Promotion Period

1. The promotion period shall run from 7 September to 31 October 2022 (both dates inclusive), or such other period(s) as may be determined by Oversea-Chinese Banking Corporation Limited ("OCBC Bank") at its absolute discretion (the "Promotion Period").

Eligibility

- 2. You will qualify for the Promotion ("Eligible Cardmember") if:
 - i. you are an existing holder of OCBC Titanium Rewards or OCBC Titanium Card (the "Eligible Card");
 - ii. you have received an electronic direct mail (eDM) or an SMS from OCBC bank inviting you to participate in the Promotion (please note that the invitation to participate in the Promotion is not transferrable);
 - iii. you have spent a minimum of S\$1,200 equivalent in Qualifying Spend (as defined below) and are among the top 5 Eligible Cardmembers with the highest amount in Qualifying Spend within the Promotion Period; and
 - iv. your Eligible Card account is active and in good standing with OCBC Bank from the start of the Promotion Period until 6 months after the end of the Promotion Period.

Definitions

- 3. "Qualifying Spend":
 - i. refers to any retail transaction (including face-to-face or online purchases);
 - ii. does not include payments or transactions relating to annual card fees, Cash-On-Instalment, Instalment Payment Plan, PayLite, extended payment plan, interest, late payment charges, cash advances, balance transfers, tax payments, bill payments made via Internet Banking, AXS or SAM network, transactions made at TransitLink General Ticketing Machines and other fees and charges.;
 - iii. does not include payments or transactions performed at merchants that fall into the exclusion categories/excluded organisations as set out below:
