

Terms & Conditions Governing the OCBC Visa Top Transactor Promotion 2022 Promotion (the "Promotion")

Promotion Period

1. The promotion period shall run from 17 August 2022 to 01 October 2022 (both dates inclusive), or such other period(s) as may be determined by Oversea-Chinese Banking Corporation Limited ("OCBC Bank") at its absolute discretion (the "Promotion Period").

Eligibility

- 2. You will qualify for the Promotion ("Eligible Cardmember") if:
 - a) you hold an Eligible Card;
 - b) your Eligible Card account is active and in good standing with OCBC Bank from the start of the Promotion Period until the point of fulfilment;
 - c) you are amongst the top 1,000 cardholders with the highest number of transactions made per week (with a minimum of 20 Qualifying Transactions) during any of the Eligible Period on your Eligible Card in accordance with the terms and conditions of the Promotion ("Minimum Qualifying Spend");

Definitions

- 3. "Eligible Cards" means any of the following OCBC Cards:

- 4. "Eligible Period" refers to any of the following period
 - a) 17 Aug 2022 20 Aug 2022
 - b) 21 Aug 2022 27 Aug 2022
 - c) 28 Aug 2022 03 Sep 2022
 - d) 04 Sep 2022 10 Sep 2022
 - e) 11 Sep 2022 17 Sep 2022
 - f) 18 Sep 2022 24 Sep 2022
 - g) 25 Sep 2022 01 Oct 2022
- 5. "Qualifying Transaction":
 - a) refers to any retail transaction (including face to face or online purchases);
 - b) does not include payments or transactions relating to annual card fees, insurance premiums, Cash-On-Instalment IPP, extended payment plan, income tax payment, bill payments made via Internet Banking, bill payments made via AXS, interest, late payment charges, goods and services taxes, cash advances, balance transfers, bus/MRT transactions, Transit top-up, contactless payments and other bank fees and charges;
 - c) does not include payments made to or transactions performed at merchants that fall into the exclusion categories/excluded organisations as set out by OCBC Bank below;

d) will be determined by its transaction date based on Singapore Timing (UTC+08:00). For avoidance of doubt, the date on which the transaction is submitted or posted may differ from the actual date the transaction was made and OCBC Bank bears no liability for any late submission or transaction posting of any purchase by any merchant that might affect the Promotion.

Promotion Mechanics

- 6. Eligible Customers who meet the conditions specified herein will receive a S\$30 cashback ("Cashback"), subject to these terms and conditions.
- 7. The maximum amount of cashback an Eligible Cardmember can earn is S\$210. To illustrate, if an Eligible Cardmember is amongst the top transactor for the entire Promotion Period of 7 weeks, he/she is able to enjoy the maximum cashback of S\$210.
- 8. For the avoidance of doubt, in the event that any person entitled to the Cashback is subsequently found to be ineligible for the Promotion, OCBC Bank shall not be obligated or liable to provide the Cashback to another Eligible Customer.
- 9. For principal cardmembers with supplementary Cards, the Cashback will be awarded for the aggregated spend on both the principal Card and supplementary Card
- 10. OCBC Bank reserves the right in its sole and absolute discretion to determine whether a transaction qualifies as a Qualifying Transaction under the Promotion. If OCBC Bank in its sole and absolute discretion decides that any transaction is not to be considered a valid transaction, the Cashback will not be awarded.

Cashback

- 11. Subject to the fulfilment of all the conditions specified in these terms and conditions to the absolute satisfaction of OCBC Bank, the Cashback will be credited into the Eligible Customer's OCBC Credit Card account where the Qualifying Transaction is made.
- 12. The Cashback will be credited by **31 October 2022**.
- 13. Applicants who had cancelled their Eligible Card within the 6 months prior to the Promotion and re-applied for it under the Promotion are not eligible to participate in the Promotion.
- 14. For each Eligible Period, an Eligible Customer is only entitled to receive a maximum of S\$30 Cashback under the Promotion.
- 15. The Promotion shall not apply in conjunction with any other privileges or promotions.



- 16. Refunded transactions will be deducted from the relevant monthly billed amount for the computation and award of the Cashback.
- 17. OCBC Bank reserves the right and at any time at its absolute discretion and without giving any reason or notice to withdraw, clawback, cancel and/or invalidate any cashback awarded to any customer without liability. A customer will not be entitled to any payment or compensation whatsoever in respect of such withdrawal, clawback, cancellation or invalidation.
- 18. OCBC Bank reserves the right to claw-back and deduct from any of the Eligible Customer's accounts with OCBC Bank the equivalent value of the Cashback if the Eligible Customer closes his/her Eligible Cardduring, or within six (6) months from the end of, the Promotion Period. If any Eligible Customer is subsequently discovered to be ineligible to participate in the Promotion or to receive the Cashback, OCBC Bank reserves the right to (i) withdraw the Cashback at any time; or (ii) claw-back the Cashback or request the relevant customer to repay to or compensate OCBC Bank the value of the Cashback or such other amount as it deems fit from the account(s) of the customer. No person shall be entitled to any payment or compensation from OCBC Bank should any Cashback be withdrawn, if any Cashback is reclaimed by OCBC Bank, or if a customer is asked to repay to or compensate OCBC Bank the value of the Cashback be withdrawn.

General

- 19. The eligibility of any Eligible Customer to participate in this Promotion and/or receive any Cashback shall be determined at the absolute discretion of OCBC Bank.
- 20. OCBC Bank reserves the right at its absolute discretion to terminate the Promotion or vary, delete or add to any of these terms and conditions at any time without notice including without limitation, the eligibility of any customer and the dates of the Promotion.
- 21. OCBC Bank shall not be responsible for the quality, merchantability or fitness for any purpose or any other aspect of the Promotion, or any product and/or service relating to the Promotion. Notwithstanding anything herein, OCBC Bank shall not at any time be responsible or held liable for any defect or malfunction in any product or the deficiency in any service provided, and/or any loss, injury, damage or harm suffered or incurred by or in connection with the Promotion, and/or the use of any product and/or service relating to the Promotion, by any person.
- 22. OCBC Bank's decisions on all matters relating to the Promotion shall be final and binding on all participants. No correspondence or appeal shall be entertained by OCBC Bank. In the event of any inconsistency between these terms and conditions and any brochure, marketing or promotional material relating to the Promotion, these terms and conditions shall prevail.
- 23. OCBC Bank shall not be responsible for any loss or damage to any person in connection with the Promotion howsoever arising, including any error in computing chances, any breakdown or malfunction in any computer system or equipment, or any notice which is misdirected or lost in the post or in transmission.
- 24. These terms and conditions shall be governed by the laws of Singapore and each participant in the Promotion irrevocably submits to the non-exclusive jurisdiction of the courts of Singapore. A person who is not a party to any agreement governed by these terms and conditions shall have no right under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any of these terms and conditions.
