

# Terms and Conditions Governing the OCBC Pay Anyone™ x Anywheel Top Up Promotion 2021 (the "Promotion")

## **Promotion Period**

1. The Promotion shall run from 1 June 2021 to 31<sup>t</sup> August 2021 (both dates inclusive), or such other period(s) as may be determined by Oversea-Chinese Banking Corporation Limited ("OCBC") and ANYWHEEL PTE. LTD. ("Anywheel") in its absolute discretion (the "Promotion Period").

# Eligibility Criteria

2. Any individual who uses OCBC Pay Anyone<sup>TM</sup> ("**PAO**") as a payment mode to top up their wallet on the Anywheel app with a minimum amount of S\$10.00 (the "**Top Up**") will qualify for the Promotion (each an "**Eligible Individual**").

# **Promotion Mechanics**

- 3. An Eligible Individual who makes a successful Top Up (each a "Qualified Individual") shall be entitled to one chance to 'spin' for a sure-win prize on the Anywheel app ("Prize").
- 4. The Prize under this Promotion will be awarded at random by Anywheel, and may include any of the following:
  - a. a 90-day Anywheel Pass
  - b. a 30-day Anywheel Pass
  - c. a 7-day Anywheel Pass
  - d. S\$1 off a 7-day Anywheel Pass

  - g. S\$2 ride coupon on Anywheel.

    - Only applicable when purchasing an Anywheel Pass. Any eligible discount will be automatically applied to your purchase.
  - c. Ride Coupon
    - Only applicable for regular trip expenses. Any eligible coupon will be automatically applied to your trip expenses at the end of your trip.
- 7. All ride coupons and all pass discount prizes have a 30-day validity period.



- 8. All coupon(s) and Anywheel Pass(es) are non-refundable, non-transferable and cannot be exchanged for money.
