

# Terms and Conditions Governing the OCBC Pay Anyone™ x Frasers Property Digital Gift Card Upsize Promotion 2021 (the "Promotion")

### **Promotion Period**

1. The Promotion shall run from 30 June 2021 to 30 September 2021 (both dates inclusive), or such other period(s) as may be determined by Oversea-Chinese Banking Corporation Limited ("OCBC") and Frasers Property Retail Management Private Limited ("Frasers") in each of its absolute discretion (the "Promotion Period").
