

# Terms and Conditions Governing the OCBC Pay Anyone<sup>™</sup> x TADA Promotion 2021 - 2022 ("Promotion")

#### 1. The Promotion

1.1. The Promotion will commence from 24<sup>th</sup> September 2021 to 30<sup>th</sup> September 2022 (both dates inclusive) on Fridays only, or such other period(s) as may be determined by Oversea-Chinese Banking Corporation ("OCBC") and MVL Foundation Pte Ltd ("TADA") in its absolute discretion ("Promotion Period").

## 2. Eligibility

2.1. The Promotion is open to all users of OCBC Pay Anyone<sup>™</sup> ("**PAO**") (each an "Eligible User").

### 3. Promotion Mechanics

- 3.1. An Eligible User who makes a successful payment via PAO for their TADA ride (the "TADA transaction") by scanning the NETS QR code generated on the TADA driver's mobile phone ("Scan and Pay Transaction") will be entitled to enjoy a S\$2 discount ("Discount") on their TADA transaction.
- 3.2. The Discount will automatically be applied at payment checkout.
- 3.3. The Discount is valid for the first 25,000 Scan and Pay Transactions that occur on each Friday of the Promotion Period.
- 3.4. The Promotion is not valid in conjunction with any other privileges or promotions or discount programmes.
- 3.5. All discounts are strictly non-refundable, non-transferable, and non-assignable.
