

Terms and Conditions Governing the OCBC Pay Anyone™ x Cathay Cineplexes – CNY 1-for-1 ‘Ah Girls Go Army’ Movie Treat Campaign 2022

1. The Promotion

- 1.1. The Promotion will commence from 1st to 28th February 2022 (both dates inclusive) or such other period(s) as may be determined by Oversea-Chinese Banking Corporation (“**OCBC Bank**”) and Cathay Cineplexes Pte Ltd (“**Cathay Cineplexes**”) in their absolute discretion (“**Promotion Period**”).

2. Eligibility

- 2.1. The Promotion is open to all OCBC Pay Anyone™ (“**PAO**”) users who meet all the requirements set out in these terms and conditions (each an “**Eligible User**”).

3. Promotion Mechanics

- 3.1. An Eligible User shall be entitled to enjoy a complimentary ‘Ah Girls Go Army’ movie ticket for each ‘Ah Girls Go Army’ movie ticket purchased through a Qualifying Transaction (the “**Promotion**”).
- 3.2. A “Qualifying Transaction” is a successful payment made via the OCBC PAO app for the purchase of an ‘Ah Girls Go Army’ movie ticket at Cathay Cineplexes outlets (executed by the Eligible User scanning the NETS QR code generated on the NETS terminal at a manned cashier counter).
- 3.3. The Promotion is only redeemable at Cathay Cineplexes physical box office (a manned cashier counter) from every Monday – Sunday (including eve of Public Holiday and Public Holiday) for same-day ticket purchases only and not valid for online booking or self-service kiosk.
- 3.4. The Promotion is valid for the first 200 Qualifying Transactions made by Eligible Users per day during the Promotion Period, capped at 1 redemption per Qualifying Transaction or while stock last.
- 3.5. The Promotion is valid only for a standard seat for a regular 2D movie.
- 3.6. The Promotion is not valid for 3D, Tamil, Hindi, Special-Priced Tickets, Movie marathon, Platinum Movie Suites and Film Festival Titles.
- 3.7. Except for the OCBC Pay Anyone™ CNY S\$5 Pineapple Glazed Medium Popcorn Combo Deal, the Promotion is not valid in conjunction with any other privileges, promotions, or discount programs.
- 3.8. The Promotion is strictly non-refundable, non-transferable, and non-assignable.
- 3.9. Any disputes regarding the Promotion or services comprising or relating to the Promotion should be resolved directly with Cathay Cineplexes.

4. General

- 4.1. The eligibility of any user to enjoy any promotion shall be determined at the absolute discretion of OCBC Bank.
- 4.2. OCBC Bank reserves the right at its absolute discretion to terminate the Promotion or vary, delete or add to any of these terms and conditions at any time without notice including without limitation, the eligibility of any user and the dates of the Promotion.
- 4.3. OCBC Bank shall not be responsible for the quality, merchantability or fitness for any purpose or any other aspect of the Promotion, or any product and/or service relating to the Promotion. Notwithstanding anything herein, OCBC Bank shall not at any time be responsible or held liable for any defect or malfunction in any product or the deficiency in any service provided, and/or any loss, injury, damage or harm suffered or incurred by or in connection with the Promotion, and/or the use of any product and/or service relating to the Promotion, by any person.
- 4.4. OCBC Bank's decisions on all matters relating to the Promotion shall be final and binding on all participants. No correspondence or appeal shall be entertained by OCBC Bank. In the event of any inconsistency between these terms and conditions and any brochure, marketing or promotional material relating to the Promotion, these terms and conditions shall prevail.
- 4.5. OCBC Bank shall not be responsible for any loss or damage to any person in connection with the Promotion howsoever arising, including any error in computing chances, any breakdown or malfunction in any computer system or equipment, or any notice which is misdirected or lost in the post or in transmission.
- 4.6. These Terms and Conditions shall be governed by the laws of Singapore and each participant in the Promotion irrevocably submits to the non-exclusive jurisdiction of the courts of Singapore. A person who is not a party to any agreement governed by these Terms and Conditions shall have no right under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any of these Terms and Conditions.
