

Terms and Conditions Governing the OCBC Pay Anyone<sup>™</sup> x Cathay Cineplexes Promotion 2021-2022 – Weekend 1-for-1 Movie Treat ("Promotion")

## 1. The Promotion

1.1. The Promotion will commence from 22<sup>nd</sup> November 2021 to 31<sup>st</sup> March 2022 (both dates inclusive) or such other period(s) as may be determined by Oversea-Chinese Banking Corporation ("OCBC") and Cathay Cineplexes Pte Ltd ("Cathay Cineplexes") in its absolute discretion ("Promotion Period").

## 2. Eligibility

2.1. The Promotion is open to all OCBC Pay Anyone™ ("PAO") users (each an "Eligible User").

## 3. Promotion Mechanics

- 3.1. An Eligible User who makes a successful payment via PAO for their purchase at Cathay Cineplexes outlets (the "Qualifying Transaction") by scanning the NETS QR code generated on the NETS terminal at manned cashier counter ("Scan and Pay Transaction").
- 3.2. An Eligible User will be entitled to enjoy a complimentary weekend movie ticket for an equivalent 'Weekend Movie Ticket' purchased (the "**Promotion**") from every Friday Sunday (including eve of Public Holiday and Public Holiday).
- 3.3. The Promotion is limited to the first 250 Scan and Pay Transactions per day on every Friday Sunday, capped at 1 redemption per successful Scan and Pay Transaction or while stock last.
- 3.4. The Promotion is only redeemable at Cathay Cineplexes physical box office (a manned cashier counter) for same-day ticket purchase only and not valid for online booking or self-service kiosk purchase.
- 3.5. The Promotion is valid for regular 2D movie for a standard seat.
- 3.6. The Promotion is not valid for 3D, Tamil, Hindi, Special-Priced Tickets, Movie marathon, Platinum Movie Suites and Film Festival Titles.
- 3.7. Except for OCBC Pay Anyone™ S\$5 Medium Popcorn Combo Deal, the Promotion is not valid in conjunction with any other privileges, promotions, or discount programs.
- 3.8. The Promotion is strictly non-refundable, non-transferable, and non-assignable.
- 3.9. Any disputes regarding the Promotion or services comprising or relating to the Promotion should be resolved directly with Cathay Cineplexes.

## 4. General

4.1. The eligibility of any user to enjoy any promotion shall be determined at the absolute discretion of OCBC Bank.

Notwithstanding anything herein, OCBC Bank shall not at any time be responsible or held liable for any defect or malfunction in any product or the deficiency in any service provided, and/or any loss, injury, damage or harm suffered or incurred by or in connection with the Promotion, and/or the use of any product and/or service relating to the Promotion, by any person.
- 4.4. OCBC Bank and Cathay Cineplexes' decisions on all matters relating to the Promotion shall be final and binding on all participants. No correspondence or appeal shall be entertained by OCBC Bank. In the event of any inconsistency between these terms and conditions and any brochure, marketing or promotional material relating to the Promotion, these terms and conditions shall prevail.
