

Terms and Conditions Governing the OCBC Pay Anyone™ x Klook Promotion – End of Year Promotion (“Promotion”)

1. The Promotion

- 1.1. The Promotion will run from 1 September to 31 December 2022 (both dates inclusive) or such other period(s) as may be determined by Oversea-Chinese Banking Corporation (“**OCBC Bank**”) and/or Klook Travel Technology Limited (“**Klook**”) in its absolute discretion (“**Promotion Period**”).

2. Eligibility

- 2.1 The Promotion is open to all individuals who make a booking using Klook’s mobile application (“**Booking**”) and who use OCBC Pay Anyone™ (“**PAO**”) as a payment mode (the “**Eligible Payment Mode**”) for the Booking (each an “**Eligible User**”).

3. Promotion Mechanics

- 3.1. Eligible Users who make a Booking:

- a) of at least S\$60 and make payment in a single transaction via the Eligible Payment Mode will be entitled to a S\$10 discount off the price of the Booking if they enter the promotion code “OCPA2210OFF”;
- b) of at least S\$300 and make payment in a single transaction via the Eligible Payment Mode will be entitled to a S\$50 discount off the price of the Booking if they enter the promotion code “OCPA2250OFF”.

Each single transaction referred to in clause 4.1(a) and (b) shall be referred to as a “**Qualifying Transaction.**”

- 3.2. The Promotion is valid for the first 336 Qualifying Transactions that meet the requirements set out in these terms and conditions during the Promotion Period. For the avoidance of doubt, in the event that any person entitled to the discount referred to in clause 4.1(a) or (b) (each a “**Discount**”) is subsequently found to be ineligible for the Promotion, OCBC Bank shall not be obligated or liable to provide the Discount to another Eligible User.
- 3.3. Only one promotion code may be applied for each Booking that meets the requirements set out in Clause 4.1 above.
- 3.4. The Promotion is not valid in conjunction with any other privileges, promotions, or discount programs.
- 3.5. All purchases are strictly non-refundable, non-transferable, and non-assignable.
- 3.6. Any disputes regarding the Promotion or services comprising or relating to the Promotion should be resolved directly with Klook.
- 3.7. OCBC Bank reserves the right in its sole and absolute discretion to determine whether a transaction qualifies as a Qualifying Transaction under the Promotion. If OCBC Bank in its sole and absolute discretion decides that any transaction is not to be considered a valid transaction, the Discount will not be awarded.

- 3.8. If any Eligible User is subsequently discovered to be ineligible to participate in the Promotion or to receive the Discount, OCBC Bank reserves the right to (i) forfeit or withdraw the Discount at any time; or (ii) (where the Discount has been redeemed) claw-back the Discount or request the relevant customer to repay to or compensate OCBC Bank the value of the Discount at any time, and OCBC Bank shall have the right to debit the value of the Discount plus any goods and services tax or such other amount as it deems fit from the account(s) of the customer. No person shall be entitled to any payment or compensation from OCBC Bank should any Discount be forfeited or withdrawn, if any Discount is reclaimed by OCBC Bank, or if a customer is asked to repay to or compensate OCBC Bank the value of the Discount for whatsoever reasons.
- 3.9. To redeem the Discount, the Eligible User will have to enter the promotion code on the Klook app.
- 3.10. The Discount is strictly not refundable and cannot be replaced if lost, damaged or expired.
- 3.11. The Discount is strictly not exchangeable for cash.
- 3.12. Redemption of the Discount is subject to Klook's terms and conditions. Please refer to Klook's website for full details.
- 3.13. OCBC Bank reserves the right to substitute or replace the Discount with any item of similar value at its sole discretion without notice to any person.

4. General

- 4.1. The eligibility of any user to participate in this Promotion and/or to receive any Discount shall be determined at the absolute discretion of OCBC Bank.
- 4.2. OCBC Bank reserves the right at its absolute discretion to terminate the Promotion or vary, delete or add to any of these terms and conditions at any time without notice including without limitation, the eligibility of any user and the dates of the Promotion.
- 4.3. OCBC Bank shall not be responsible for the quality, merchantability or fitness for any purpose or any other aspect of the Promotion, or any product and/or service relating to the Promotion. Notwithstanding anything herein, OCBC Bank shall not at any time be responsible or held liable for any defect or malfunction in any product or the deficiency in any service provided, and/or any loss, injury, damage or harm suffered or incurred by or in connection with the Promotion, and/or the use of any product and/or service relating to the Promotion, by any person.
- 4.4. OCBC Bank's decisions on all matters relating to the Promotion shall be final and binding on all participants. No correspondence or appeal shall be entertained by OCBC Bank. In the event of any inconsistency between these terms and conditions and any brochure, marketing or promotional material relating to the Promotion, these terms and conditions shall prevail.
- 4.5. OCBC Bank shall not be responsible for any loss or damage to any person in connection with the Promotion howsoever arising, including any error in computing chances, any breakdown or malfunction in any computer system or equipment, or any notice which is misdirected or lost in the post or in transmission.
- 4.6. These Terms and Conditions shall be governed by the laws of Singapore and each participant in the Promotion irrevocably submits to the non-exclusive jurisdiction of the courts of Singapore. A person who is not a party to any agreement governed by these Terms and Conditions shall have no right under the Contracts (Rights of Third Parties) Act 2001 to enforce any of these Terms and Conditions.
