

Terms and Conditions Governing the OCBC Pay Anyone™ x Timezone Promotion 2021 ("Promotion")

1. The Promotion

1.1. The Promotion will commence from 15th November 2021 to 14th January 2022 (both dates inclusive) or such other period(s) as may be determined by Oversea-Chinese Banking Corporation ("**OCBC**") and Timezone Singapore Private Limited ("**Timezone**") in their absolute discretion ("**Promotion Period**").
