Appendix B

Terms and Conditions Governing the PayNow x Jun Jie Promotion (the “Promotion”)

1. The Promotion

- 1.1. This Promotion is conducted by Jun Jie and open to all of Jun Jie’s customers who use PayNow.
- 1.2. The Promotion will commence from 21 April 2022 to 31 May 2022 (both dates inclusive) or such other period(s) as may be determined by Jun Jie in its absolute discretion (“Promotion Period”).

2. Eligibility

- 2.1. The Promotion is open to all of Jun Jie’s customers who make a Qualifying Transaction at Jun Jie’s outlet located at 1 Liang Seah Street #01-07/08 S189022 & 494 North Bridge Road S188738. (Each an “Eligible Customer”).
- 2.2. A “Qualifying Transaction” is a successful PayNow transaction executed by scanning a PayNow QR Code (“Scan and Pay Transaction”) for the payment of goods and services, with a minimum spend of S\$50, before any applicable service charges or taxes, in a single transaction (“Minimum Spend”).

3. Promotion Mechanics

- 3.1. An Eligible Customer who makes a Qualifying Transaction shall be entitled to enjoy a discount of S\$25 off his total bill (“Discount”).
- 3.2. The Discount will automatically be applied upon payment checkout.
- 3.3. The Discount shall only be valid for the first 160 Eligible Customers who make a Qualifying Transaction during the Promotion Period.
- 3.4. The first 160 Eligible Customers who make a Qualifying Transaction during the Promotion Period will be equally split between both outlets located at 1 Liang Seah Street #01-07/08 S189022 & 494 North Bridge Road S188738.
- 3.5. The Promotion is not valid in conjunction with any other privileges, promotions, or discount programmes.
- 3.6. All Discounts are strictly non-refundable, non-transferable, and non-assignable.
- 3.7. The Discount shall be limited to the first 10 Eligible Customers per day during the Promotion Period. Not valid on weekends and public holidays.
- 3.8. Valid for dine-in only.
- 3.9. The Discount is not valid with the reservation made through external platforms.

In the event of any inconsistency between these terms and conditions and any brochure, marketing or promotional material relating to the Promotion, these terms and conditions shall prevail.

Jun Jie shall not be responsible for any loss or damage to any person in connection with the Promotion howsoever arising, including any error in computing chances, any breakdown or malfunction in any computer system or equipment, or any notice which is misdirected or lost in the post or in transmission.
